ORDER APPROVING A CHANGE IN PLACE OF USE

Pursuant to ORS 540.510 to 540.530, after notice was given and no objections were filed, and finding that no injury to existing water rights would result, this order approves, as conditioned or limited herein, TRANSFER 7568 submitted by

GREG AND ARLENE VANDEHAY 7874 NW SPREADBOROUGH LANE FOREST GROVE, OREGON 97116.

The right to be modified, as evidenced by a portion of Certificate 23484, was perfected under Permit 19737 with a date of priority of JULY 31, 1950. The right allows the use of WEST FORK DAIRY CREEK, a tributary of the TUALATIN RIVER, for IRRIGATION OF 7.2 ACRES. The amount of water to which this right is entitled is limited to an amount actually beneficially used and shall not exceed 0.03 cubic foot per second, if available at the authorized points of diversion: SW% NE%, SECTION 13, T 1 N, R 4 W, W.M., AND SE% NW%, SECTION 18, T 1 N, R 4 W, W.M., or its equivalent in case of rotation, measured at the point of diversion from the source.

The amount of water used for irrigation, together with the amount secured under an other right existing for the same lands, is limited to ONE-EIGHTIETH of one cubic foot per second per acre or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 2½ acre-feet for each acre irrigated during the irrigation season of each year.

The use shall conform to any reasonable rotation system ordered by the proper state officer.

The authorized place of use is located as follows:

NE¼ NW¼ 1.3 ACRES
SE¼ NW¼ 5.9 ACRES
SECTION 18
TOWNSHIP 1 NORTH, RANGE 3 WEST, W.M.

The right to use the water for the above purpose is restricted to beneficial use on the lands or place of use described

The applicant proposes to change the place of use to:

NE% NW% 7.2 ACRES SECTION 18 TOWNSHIP 1 NORTH, RANGE 3 WEST, W.M.

THIS CHANGE TO AN EXISTING WATER RIGHT MAY BE MADE PROVIDED THE FOLLOWING CONDITIONS ARE MET BY THE WATER USER:

- 1. The proposed change shall be completed on or before October 1, 1998.
- The former place of use shall no longer be irrigated as a part of this water right.

Certificate 23484 is cancelled. A new certificate will be issued to confirm that portion of the right NOT involved in this transfer. When satisfactory proof of the completed change is received, a new certificate confirming this water right will be issued.
