### **Findings of Fact**

- On October 20, 2010, the Department issued an order determining satisfactory proof on Transfer Application T-10242. This order reduced the water rights evidenced by Certificate 83571 and 76714 by 0.4 acre. The order was recorded at Special Order Volume 82, Pages 1151 – 1153.
- 2. The order contains scrivener's error in the quantity by which Certificate 83571, at point of diversion #1, would be reduced. The *incorrect* quantities listed in the order were:
