Findings of Fact

Background

Use:

1. On February 18, 2010, MT. HOOD ROCK PRODUCTS filed an application for an additional point of appropriation under Permit G-13465. The Department assigned the application number T-11019.

The permit to be amended is as follows:

3. Permit Amendment Application T-11019 proposes an additional point of appropriation currently located approximately 350 to 1225 feet northwest from the existing points of appropriation to:

4. Notice of the application for the permit amendment was published in the Department's weekly notice on February 23, 2010, and in the Sandy Post newspaper on September 1, 18, and 15, 2010, pursuant to ORS 540.520(5). No comments were filed in response to the notices.

Permit Amendment Review Criteria

- 5. The change would not result in injury to other water rights.
- The change does not enlarge the permit.
- The change does not alter any other terms of the permit.

Conclusions of Law

The additional point of appropriation proposed by Permit Amendment Application T-11019 is consistent with the requirements of ORS 537.211.

Now, therefore, it is ORDERED:

The change and subsequent use of water shall be subject to the following conditions:

- 1. The combined quantity of water diverted at the new point of appropriation, together with that diverted at the old points of appropriation, shall not exceed the quantity of water lawfully available at the original points of appropriation.
- 2. Measurement, recording and reporting conditions:
 - a. Before water use may begin under this order, the water user shall install a totalizing flow meter, or, with prior approval of the Director, another suitable measuring device, at the proposed point of appropriation.

- b. The water user shall maintain the meters or measuring devices in good working order.
- c. The water user shall allow the Watermaster access to the meters or measuring devices; provided however, where the meters or measuring devices are located within a private structure, the Watermaster shall request access upon reasonable notice.
- 3. Water shall be acquired from the same aquifer as the original points of appropriation.
- 4. All other terms and conditions of Permit G-13465 remain the same.
- 5. Permit G-13465, in the name of JIM TURIN AND SONS INC., DBA MT HOOD ROCK PRODUCTS, JAMES C. TURIN, PRESIDENT, is amended as described herein.
