- 9. The water rights are subject to transfer as defined in OAR 690-385-0100(17).
- 10. The proposed change in places of use will not result in enlargement of the rights.
- 11. The proposed change in places of use will not result in injury to other water rights.

***Partial Cancellation of Water Rights***

12. On February 10, 2011, affidavits certifying that portions of water right Certificate 19643 have been abandoned and requesting cancellation of the right were received from Eagle Point Irrigation District. The right to be cancelled is as follows:

**Certificate:** 19643 in the name of EAGLE POINT IRRIGATION DISTRICT

**Use:** SUPPLEMENTAL IRRIGATION of 10.4 ACRES

**Priority Date:** MARCH 2, 1948

**Rate:** 0.131 CUBIC FOOT PER SECOND, being 0.096 CFS from LITTLE BUTTE CREEK, and 0.338 CFS from WASTE WATER

**Limit:** The amount of water used for irrigation under this right, together with the amount secured under any other right existing for the same lands, shall be limited to ONE-EIGHTIETH of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 4.5 acre-feet per acre for each acre irrigated during the irrigation season from April 2 to October 31, of each year; provided further that the amount of water allowed herein, together

with the amount secured under any other right existing for the same lands shall not exceed the limitation allowed herein, and shall also be limited to the water available at the proposed point of diversion of waste water, and shall not carry with it the right to compel the continuance of the waste water.


**Conclusions of Law**

The proposed changes in place of use as proposed in Transfer Application T-11179 satisfy the requirements of ORS 540.574(3) and 540.580. The partial cancellations are consistent with ORS 540.621 and the abandoned lands are cancelled.

**Now, therefore, it is ORDERED:**

1. The proposed changes in place of use to the water rights evidenced by Certificates 68741 and 75429 are approved.
2. The right to the use of the water is restricted to beneficial use at the place of use described and is subject to all other conditions and limitations contained in Certificates 68741 and 75429 and any related decree.
3. The former places of use shall no longer be irrigated as part of these water rights.
4. The approved changes shall be completed and full beneficial use of the water shall be made on or before October 1, 2011.
5. A Claim of Beneficial Use (COBU) shall be submitted by the applicant to the Department by October 1, 2012.
6. Water right certificates 68741 and 75429 are modified. The Department will issue superseding certificates describing the rights when it determines that is necessary for record keeping.
7. Water Right Certificates 19643 and 84273 are cancelled. New certificates will be issued describing those portions of the rights not affected by this transfer and cancellation.
