Authority

ORS 537.348 establishes the process in which a water right holder may submit a request to lease an existing water right for instream purposes. OAR Chapter 690, Division 077 implements the statutes and provides the Department's procedures and criteria for evaluating instream lease applications.

Findings of Fact

- 1. On June 2, 2014 Manton Carl, LLC, filed an application to renew instream lease IL-947, involving the entirety of Certificates 57994, 27061, 12243, 13463, and 26055.
- 2. The first right to be leased is as follows:

- 7. Certificate 26055 includes the diversion of water from an unnamed reservoir. In Section 1.5 of the lease application, the source of water for the proposed lease is described as only being from the unnamed drainage ditch. The lease of water under certificate 26055 shall be limited to live flow from the unnamed drainage ditch.
- 8. None of the certificate to be leased specify the irrigation season. However, the Willamette Basin Program establishes the irrigation season for the area as March 1 to October 31.
- 9. The POD for Certificates 27061 and 12243 appears to be the same as that of Certificate 57994, as described in Finding of Fact No. 2. For purposes of this lease, the POD described in Finding of Fact No. 2 shall be used as the starting point for the instream use associated with these certificates.
- 10. The POD for Certificate 13463 and 26055 is located near where Carl Road crosses the unnamed stream. For purposes of this lease, where the road crosses the unnamed stream shall be used as the starting point of the instream use associated with these Certificates.
- 11. The lease application includes the information required under OAR 690-077-0076(3). The Department provided notice of the lease application pursuant to OAR 690-077-0077(1). No comments were received.
- 12. The Lessor has requested to limit the amount of water protected instream under Certificate 26055 to 129.8 AF. The full duty allowed under this right is 141.25 AF (2.5 acre-feet per acre during the irrigation season). The requested limitation is to account for stored water that may also be used under this right but is not being leased instream.

13. The instream use is as follows:

- 14. The amount and timing of the proposed instream flow is allowable within the limits and use of the original water right(s).
- 15. The protection of flows within the proposed reach is appropriate, considering:
 - a. The instream water use begins at the recorded point of diversion;
 - b. The location of confluences with other streams downstream of the point of diversion.
 - c. There are no known areas of natural loss of streamflow to the river bed downstream from the point of diversion; and
 - d. Any return flows resulting from the exercise of the existing water right would re-enter the river downstream of the reach of the instream water right.
- 16. The total monthly quantities of water to be protected under the existing and proposed instream rights in the reach will provide for a beneficial purpose.
- 17. The total monthly quantities of water to be protected instream under existing and proposed instream rights in the reach do not exceed the estimated average natural flow.
- 18. If approved, this instream lease is not reasonably expected to significantly affect land use as prescribed by ORS 197.180, OAR Chapter 660, Divisions 30 and 31, and OAR Chapter 690, Division 5.
- 19. Based upon review of the application, information provided by the Department's Watermaster, and other available information, the Department finds that the lease will not

result in injury or enlargement. The order approving this instream lease may be modified or revoked under OAR 690-077-0077 if the Department later finds that the lease is causing injury to any existing water right or enlargement of the original right.

- 20. If a right which has been leased is later proposed to be leased again, transferred and/or reviewed for an allocation of conserved water, a new injury review shall be required. For example, instream transfers will be subject to a full and complete review to determine consistency with the requirements of OAR Chapter 690, Division 380 and Division 077. Approval of this lease does not establish a precedent for approval of any future transactions.
- 21. The Lessor has requested that the lease terminate on October 31, 2018. The lease may commence on the date this final order is signed.
- 22. The Lessor has requested the option of terminating the lease early with written notice to the Department.

Conclusions of Law

The Department concludes that the lease will not result in injury or enlargement, OAR 690-077-0077. The lease conforms to the applicable provisions of OAR 690-077-0015.

Now, therefore it is ORDERED:

- 1. The Lease as described herein is APPROVED.
- 2. During each year of the term of the lease, the former place of use will no longer receive water as part of these rights, any supplemental rights, or any other layered irrigation water rights, including ground water registrations and permits.
- 3. The term of the lease will commence upon approval of the instream lease and terminate on October 31, 2018. For multiyear leases, the lessor shall have the option of terminating the lease any time each year with written notice to the Department. However, if the termination request is received less than 30-days prior to the instream use period (June 1 through September 8) or after the water rights' original period of allowed use has begun, the Department may issue an order terminating the lease but use of water may not be allowed until the following calendar year, unless the Director determines that enlargement would not occur.
