ORDER

An affidavit was received from ROBERT L. LEVY, dba L & L FARMS, and TRUSTEE FOR ROBERT L. LEVY FAMILY TRUST, the owner of certain land and the water rights appurtenant to it. The water right records show two rights as primary on this land. The groundwater right has been requested to be diminished from primary to supplemental.

The water right is a portion of the right described by Certificate 72395, State Record of Water Right Certificates. The water right is for the use of 3.0 cfs from WELL 1 in the SPIKES GULCH BASIN. The date of priority is JULY 19, 1976. The water right to be diminished is for IRRIGATION of 356.2 ACRES.

A description of the place of use of the water right is as follows:

OAR 690-330-040(2) states: "Diminution of a water right: A primary right may, at the request of the owner of the right, be diminished to a supplemental status to allow for a new primary right application from a more dependable source of water."

NOW, THEREFORE, it is ORDERED that the portion of the water right described herein is diminished to SUPPLEMENTAL IRRIGATION. It is FURTHER ORDERED that Certificate 72395 is canceled and a new certificate be issued to confirm this order.
