The water right is a portion of the right described by Certificate 61532, State Record of Water Right Certificates. The water right is for the use of 7.06 cubic feet per second from PRIOR WELLS 4, 7, AND 8; a tributary of the UMATILLA RIVER BASIN. The date of priority is SEPTEMBER 5, 1974. The water right to be diminished is for IRRIGATION of 564.2 ACRES.
