FINAL ORDER

March 3, 2000

RE: Approval of District Temporary Transfer File T-8424 (Lane Pollock)

Pursuant to ORS 540.570, Westland Irrigation District filed a request to move the place of use of certain water rights within the District for the 2000 irrigation season. The changes requested are enumerated on the attached sheet. Notice of the request was published in summary form by the Water Resources Department on February 1, 2000. Public comments were accepted for 30 days following publication. No comments were received.

Pursuant to ORS 540.570 (3) and OAR 690-21-060 (2), staff have reviewed the requested changes. This review finds that the proposed changes do not injure existing rights or result in enlargement of the subject rights. Therefore, the request as enumerated on the attached sheet and as conditioned below, is approved for the 2000 irrigation season.

- 1. Pursuant to 540.570 (2) water will not be used on the subject lands until 60 days after the district's notice was received or the start of the irrigation season, whichever is later. The notice was received January 24, 2000. Water will not be used on the subject lands until March 23, 2000.
- 2. The "FROM" lands will receive no water under the rights involved with T-8424 for the 2000 irrigation season.

This is an order other than contested case. This order is subject to judicial review under ORS 183.484. Any petition for judicial review must be filed within the 60 day time period specified by ORS 183.484(2).

Pursuant to ORS 536.075 and OAR 137-004-080 and OAR 690-01-005, you may either petition for judicial review or petition the Director for reconsideration of this order.

- 3. The "FROM" lands will receive no water under any other rights appurtenant to these lands for the 2000 irrigation season, unless water rights are transferred to the "FROM" lands. In no case shall a temporary transfer allow the enlargement of the water right.
- 4. There are existing water rights evidenced by Certificates 49732 (G-6879), 14346 (S-13306) and Permit G-7913 on portions of the land to which this application requests to move water. The water user shall not use water under the existing water rights evidenced by Certificates 49732 (G-6879), 14346 (S-13306) and Permit G-7913 on this land during the 2000 irrigation season.
- 5. All restrictions and limitations contained in the decree or permit of the subject rights will apply to the "TO" lands.
- 6. Pursuant to 540.570 (6), the Department may further condition or revoke a temporary transfer at any time to the extent necessary to avoid injury if the department finds the transfer is causing injury to an existing water right.
- 7. Pursuant to 540.570 (7), upon expiration of the temporary transfer period, all uses of water for which a temporary transfer is allowed under this section shall revert automatically to the terms and conditions of the original water right permit, certificate or an adjudication proceeding under ORS chapter 539 as evidenced by a court decree.

Copies of the approved request and associated maps are on file at the Department's North Central Region office in Pendleton.
