**CORRECTING FINAL ORDER**

**Findings of Fact**

1. On September 28, 2015, the Department issued an order approving Transfer Application T-11898. The order was recorded at Special Order Volume 96, Pages 964 - 969.
2. A scrivener's error was found in the order on page 968.
3. The scrivener's error was found in the proposed point of appropriation table in Finding No. 10 on Page 968. The table inaccurately describes the quarter-quarter (Q-Q) designation of the proposed additional POA as being in the SW NW quarter-quarter of Section 9, Twp. 2 S. Rng. 1 W.:

2. All other provisions of the order approving T-11898 are unchanged.
