Jeffries and recorded at page 22995, Volume 16, State Record of Water Right Certificates, confirms a right under Permit No. 20544 for the use of the waters of an unnamed stream and reservoir for the irrigation of 8.5 acres in the SW1, NE4, 10.1 acres in the SE4 NE4, 1.4 acres in the SE4 NW4, 2.0 acres in the NE4 SW4, 17.0 acres in the NB4 SE4 and 14.0 acres in the NW4 SE4, as projected in John S. Jeffries and recorded at page

22995, Volume 10, State Record of Water Hight Certificates, shall be canceled.
