ORDER APPROVING A CHANGE IN USE

Pursuant to ORS 537.705 and 540.510 to 540.530, after notice was given and no objections were filed, and finding that no injury to existing water rights would result, this order approves, as conditioned or limited herein, TRANSFER 6966 submitted by

PORT OF MORROW
P.O. BOX 200
BOARDMAN, OREGON 97818.

The right to be modified, AS EVIDENCED BY CERTIFICATE 51782, was perfected under Permit G-8619 with a date of priority of June 4, 1979. The right allows the use of two wells, tributary of the Columbia River Basin, for IRRIGATION of 544.2 acres. This right is limited to 4.0 cubic feet per second from Sump Well #1 and 2.8 cubic feet per second from Sump Well #2, if available at the authorized points of diversion: Sump Well #1 being 1300 feet North and 440 feet West from East $\frac{1}{4}$ corner, Section 10, SE $\frac{1}{4}$ NE $\frac{1}{4}$ Township 4 North, Range 25 East W.M., Sump Well #2 being 1250 feet North and 100 feet West from East $\frac{1}{4}$ corner, Section 10, SE $\frac{1}{4}$ NE $\frac{1}{4}$ Township 4 North, Range 25 East; or its equivalent in case of rotation, measured at the point of diversion from the source.

The amount of water used for irrigation under this right is limited to a diversion of ONE-EIGHTIETH of one cubic foot per second (or its equivalent) and 3 acre-feet for each acre irrigated during the irrigation season of each year.

The right to use water for the above purpose is restricted to beneficial use on the lands or place of use described.


The applicant proposes to change the TYPE of use to MUNICIPAL USE, the PERIOD of use to 12 months and PLACE OF USE to THE PORT OF MORROW SERVICE AREA NEAR BOARDMAN, OREGON.

THESE CHANGES TO AN EXISTING WATER RIGHT MAY BE MADE PROVIDED THE FOLLOWING CONDITIONS ARE MET BY THE WATER USER:

1. The proposed change shall be completed on or before October 1, 1995.
2. The use of water shall be limited to 2.26 cfs and shall not exceed a total diversion of 1,632.60 acre feet per year.
3. When required by the Department, the water user shall install an in-line flow meter or other suitable device for measuring and recording the quantity of water used. The type and plans for the measuring device must be approved by the Department prior to beginning construction and shall be installed under the general supervision of the Department.
4. Water shall be acquired from the same aquifer as the original point of appropriation.

Certificate 51782 is cancelled. When satisfactory proof of the completed change is received, a new certificate confirming this water right will be issued.
