ORDER APPROVING A CHANGE IN CHANGE IN PLACE OF USE

Pursuant to ORS 540.510 to 540.530, after notice was given and no objections were filed, and finding that no injury to existing water rights would result, this order approves, as conditioned or limited herein, TRANSFER 7364 submitted by

HUGH MALPASS 92969 COBURG ROAD HARRISBURG, OREGON 97446.

The first right to be modified, as evidenced by a portion of Certificate 68346, was perfected under Permit 17510 with a date of priority of FEBRUARY 9, 1939. The right allows the use of the McKenzie River, a tributary of the Willamette River, for Irrigation OF 17.5 Acres. The amount of water to which this right is entitled is limited to an amount actually beneficially used and shall not exceed 0.22 cubic foot per second, if available at the authorized point of diversion: Ne¼ Ne¼, as projected within Spores DLC 38, Section 9, T 17 S, R 3 W, WM; 4440 FEET SOUTH AND 5250 FEET EAST FROM THE SE CORNER, MANSFIELD DLC 79, T 17 S, R 3 W, WM, or its equivalent in case of rotation, measured at the point of diversion from the source.

The amount of water used for irrigation, together with the amount secured under an other right existing for the same lands, is limited to ONE-EIGHTIETH of one cubic foot per second per acre or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 3 acre-feet for each acre irrigated during the irrigation season of each year.

The second right to be modified, as evidenced by a portion of Certificate 68365, was perfected under Permit 50921 with a date of priority of AUGUST 13, 1986 FOR 0.003 CUBIC FOOT PER SECOND AND OCTOBER 2, 1986 FOR 0.07 CUBIC FOOT PER SECOND. The right allows the use of the McKENZIE RIVER, a tributary of the WILLAMETTE RIVER, for IRRIGATION OF 6.0 ACRES. The amount of water to which this right is entitled is limited to an amount actually beneficially used and shall not exceed 0.073 cubic foot per second, if available at the authorized point of diversion: NE¼ NE¾, as projected within SPORES DLC 38, SECTION 9, T 17 S, R 3 W, WM; 4440 FEET SOUTH AND 5250 FEET EAST FROM THE SE CORNER, MANSFIELD DLC 79, T 17 S, R 3 W, WM, or its equivalent in case of rotation, measured at the point of diversion from the source.

The amount of water used for irrigation, together with the amount secured under an other right existing for the same lands, is limited to ONE-EIGHTIETH of one cubic foot per second per acre or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 2½ acre-feet for each acre irrigated during the irrigation season of each year.

The use shall conform to any reasonable rotation system ordered by the proper state officer.

2. The former place of use shall no longer be irrigated as a part of this water right.

Certificate is cancelled. A new certificate will be issued to confirm that portion of the right NOT involved in this transfer. When satisfactory proof of the completed change is received, a new certificate confirming this water right will be issued.
