ORS 537.705 and 540.505 to 540.580 establish the process in which a water right holder may submit a request to transfer the point of appropriation, place of use, or character of use authorized under an existing water right. OAR Chapter 690, Division 380 implements the statutes and provides the Department's procedures and criteria for evaluating transfer applications. ORS 537.211 establishes the process in which a water right permit holder may submit a request to change the place of use authorized under an existing water right permit.

#### **Findings of Fact**

- 1. On December 13, 1999, Glenn Chowning filed an application to add an additional point of appropriation to Certificates 65153 and 80375, to change the point of appropriation under Certificate 51993, and to change the place of use under Certificates 51993, 65152, 65153, 75766, 80301, and 80375. The Department assigned the application number T-8376.
- 2. On June 6, 2003, Glenn Chowning filed an application to amend the place of use under Permit G-13419. The Department assigned the application number T-9488.

This is a final order in other than contested case. This order is subject to judicial review under ORS 183.484. Any petition for judicial review must be filed within the 60 day time period specified by ORS 183.484(2). Pursuant to ORS 536.075 and OAR 137-004-080 and OAR 690-01-005 you may either petition for judicial review or petition the Director for reconsideration of this order. A petition for reconsideration may be granted or denied by the Director, and if no action is taken within 60 days following the date the petition was filed, the petition shall be deemed denied.

- 20. Notice of the application for transfer was published pursuant to ORS 540.520 and OAR 690-380-4000. No comments were filed in response to the notice.
- 21. Notice of the application for permit amendment was published pursuant to ORS 540.520(5). No comments were filed in response to the notice.
- 22. Water has been used within the last five years according to the terms and conditions of the rights, and no evidence is available that would demonstrate that any of the rights are subject to forfeiture under ORS 540.610.
- 23. A pump, pipeline, and sprinkler system sufficient to use the full amount of water allowed under the existing rights are present.
- 24. The authorized point of appropriation, Well 1, for Certificate 51993 is located within the Ordnance Critical Groundwater Area (OCGWA).
- 25. The proposed points of appropriation, Deep Well 2 and Hillview Well 4, to replace Well 1, will be subject to the same provisions of the OCGWA order as the original point of appropriation.
- 26. The proposed place of use for Permit G-13419 is owned and/or controlled by the permit holder.

- 27. The portion of Permit G-13419 that is located on the proposed place of use of the primary irrigation under Certificates 51993 and 75766 in application T-8376 will be claimed as supplemental irrigation at time of final proof of the permit.
- 28. The proposed place of use for Permit G-13419 is contiguous to the authorized place of use.
- 29. The proposed changes would not result in enlargement of the water rights and water right permit.
- 30. The change does not alter any other terms of Permit G-13419.
- 31. The proposed changes would not result in injury to other water rights.
- 32. A scrivener's error was found in Permit G-13419. The authorized place of use description on the permit lists the following acres as being primary irrigation:

The acreages should be described as supplemental irrigation.

#### Conclusions of Law

The changes in point of appropriation, additional points of appropriation and place of use proposed in application T-8376 are consistent with the requirements of ORS 537.705 and 540.505 to 540.580, and OAR 690-380-5000.

The change in place of use proposed by Permit Amendment Application T-9488 is consistent with the requirements of ORS 537.211.

#### Now, therefore, it is ORDERED:

- 1. The changes in point of appropriation, additional points of appropriation and place of use proposed in application T-8376 are approved.
- 2. The change in place of use proposed in application T-9488 is approved.

- 3. Water right Certificates 51993, 65152, 65153, 75766, 80301, and 80375 are cancelled. New certificates will be issued to confirm those portions of the rights described by Certificates 52993, 75766, and 80301, not involved in this transfer.
- 4. The right to use of the water is restricted to beneficial use at the place of use described, and is subject to all other conditions and limitations contained in Certificates 51993, 65152, 65153, 75766, 80301, 80375, and any related decree.
- 5. Water shall be acquired from the same aquifers (water sources) as the original points of appropriation.
- 6. The proposed changes under application T-8376 shall be completed on or before October 1, 2005.
- 7. A Claim of Beneficial Use for application T-8376, prepared by a Certified Water Rights Examiner, shall be submitted by the applicant to the Department by October 1, 2006.
- 8. The quantity of water diverted at the new points of appropriation, together with that diverted at the original points of appropriation, shall not exceed the quantity of water lawfully available at the original points of appropriation.
- 9. Prior to diverting water at the new points of appropriation, the water user shall install and maintain in-line flow meters or other suitable devices for measuring and recording the quantity of water appropriated. The type and plans of the measuring devices must be approved by the Department prior to beginning construction and shall be installed under the general supervision of the Department.
- 10. The portion of Permit G-13419 that is located on the proposed place of use of the primary irrigation under Certificates 51993 and 75766 in application T-8376 will be claimed as supplemental irrigation at time of final proof of the permit.
- 11. All other terms and conditions of Permit G-13419 shall remain the same.
- 12. Permit G-13419, in the name of Terra Poma Land Co. LLC, Glenn Chowning, is amended as described herein.
- 13. When satisfactory proof of the completed changes is received for application T-8376, new certificates confirming the rights transferred under T-8376 will be issued.
