- 6. Notice of the application for transfer was published pursuant to ORS 540.520 and OAR 690-380-4000. No comments were filed in response to the notice.
- 7. Water has been used within the last five years according to the terms and conditions of the rights, and no evidence is available that would demonstrate that the rights are subject to forfeiture under ORS 540.610.
- 8. A distribution system sufficient to use the full amount of water allowed under the existing rights is present.
- 9. The proposed change would not result in enlargement of the rights.
- 10. The proposed change would not result in injury to other water rights.
- 11. Notice of the Preliminary Determination was published pursuant to OAR 690-380-4020 in the Department's Weekly Public Notice on April 18, 2006 and in the Rogue River Press newspaper on May 3, 10 and 17, 2006. No protests were filed in response to the notice.

Conclusions of Law

The change in place of use and change in points of appropriation proposed in application T-10024 appear to be consistent with the requirements of ORS 537.705, 540.505 to 540.580, and OAR 690-380-5000.

- 1. The changes proposed in T-10024 are approved.
- 2. The right to use of the water is restricted to beneficial use at the place of use described, and is subject to all other conditions and limitations contained in Certificates 28916, 57266, and any related decree.

- 3. Water right certificates 28916 and 57266 shall be cancelled.
- 4. Water shall be acquired from the same aquifer (water source) as the original points of appropriation.
- 5. The approved changes shall be completed and full beneficial use of the water shall be made on or before **October 1, 2011.** A Claim of Beneficial Use prepared by a Certified Water Rights Examiner shall be submitted by the applicant to the Department within one year after the deadline for completion of the changes and full beneficial use of the water.
- 6. The quantity of water diverted at the new points of appropriation shall not exceed the quantity of water lawfully available at the original points of appropriation (total of 0.98 cfs for the two rights).
- 7. Prior to diverting water at the new points of appropriation, the water user shall install and maintain an in-line flow meter(s) or other suitable device(s) for measuring and recording the quantity of water appropriated. The type and plans of the measuring device(s) must be approved by the Department prior to beginning construction and shall be installed under the general supervision of the Department.
- When satisfactory proof of the completed changes is received, new certificates will be issued.
