## **Findings of Fact**

 On October 2, 2008, the Department received an application for extension of time for transfer of water right T-8707 from Chad & Tina Roberts, Gina & Glen Phillips, Tim & Lori Abell, Gary & Julie Walls, Deborah Long & Phil Payton, Ronald & Diana Baker, Robert Irving, MV Conger & DS Craig-Conger, Stacee Bahadar & Jesus Sanchez, and Rodney & Janet Fetter.

This is a final order in other than contested case. This order is subject to judicial review under ORS 183.484. Any petition for judicial review must be filed within the 60 day time period specified by ORS 183.484(2). Pursuant to ORS 536.075 and OAR 137-004-0080 you may either petition for judicial review or petition the Director for reconsideration of this order. A petition for reconsideration may be granted or denied by the Director, and if no action is taken within 60 days following the date the petition was filed, the petition shall be deemed denied.

- 2. The Water Resources Department issued an order approving Transfer Application T-8707 in the name of Chad & Tina Roberts, Gina & Glen Phillips, Tim & Lori Abell, Gary & Julie Walls, Deborah Long & Phil Payton, Ronald & Diana Baker, Robert Irving, MV Conger & DS Craig-Conger, Mike & Jolene Krieger, and Rodney & Janet Fetter, on November 22, 2004. The order was recorded in Special Order Volume 62, at Page 226. The order set a transfer completion date of October 1, 2006.
- 3. The Water Resources Department issued an assignment from Michael & Jolene Krieger, to Jesus Sanchez & Stacee Bahadar on August 20, 2008.
- 4. The applicants have completed the installation of all meters except for Lot 1200, 1600 and 1900. A total of 13.5 acres have been irrigated.
- 5. In order to fully comply with the terms and conditions of the transfer order, the applicants need to install a meter in Lot 1200 and connect the meter to the system. Lots 1600 and 1900 have a meter installed however they need to connect to the system.
- 6. The applicants have requested that the time for completion of beneficial use be extended to October 1, 2009.

#### **Conclusions of Law**

Pursuant to OAR 690-380-6020, the Director of the Water Resources Department concludes the applicants have shown reasonable diligence to complete the transfer within the time period established by the order approving Transfer Application T-8707.

#### Now, therefore, it is ORDERED:

The time for completion of beneficial use authorized by T-8707 shall be extended to October 1, 2009.
