**Authority**

OAR Chapter 690, Division 086, establishes the process and criteria for approving water management and conservation plans required under the conditions of permits, permit extensions and other orders of the Department.

**Findings of Fact**

1. The City of Tigard submitted a draft Water Management and Conservation Plan (plan) to the Department on May 4, 2010. The plan was submitted voluntarily as a result of a new intergovernmental agreement between the Cities of Tigard and Lake Oswego.
2. The Department published notice of receipt of the plan on May 11, 2010, as required under OAR Chapter 690, Division 086. Timely comments were received from WaterWatch of Oregon on June 10, 2010.
3. The Department provided comments on the plan to the City on August 19, 2010, and, in response, the City submitted revisions to the plan on April 13, 2011. The City then submitted their Final revised plan to the Department on August 10, 2011.
4. The Department reviewed the revised plan and the comments received and finds that the plan is generally consistent with the relevant requirements under OAR Chapter 690, Division 086.
5. On August 16, 2011, the Department issued a Proposed Final Order to approve the City's plan. The deadline for appeals to the Proposed Final Order was September 15, 2011. No appeals to the Proposed Final Order were received by the Department.

**Conclusion of Law**


The Water Management and Conservation Plan submitted by the City of Tigard is consistent with the criteria in OAR Chapter 690, Division 086.

This is a final order in other than a contested case. This order is subject to judicial review under ORS 183.484. Any petition for judicial review must be filed within the 60-day time period specified by ORS 183.484(2). Pursuant to ORS 536.075 and OAR 137-004-0080, you may petition for judicial review or petition the Director for reconsideration of this order. A petition for reconsideration may be granted or denied by the Director, and if no action is taken within 60 days following the date the petition was filed, the petition shall be deemed denied.

**Now, therefore, it is ORDERED:**

1. The City of Tigard's Water Management and Conservation Plan is approved and shall remain in effect until September 22, 2021, unless this approval is rescinded pursuant to OAR 690-086-0920.
2. The City of Tigard shall submit an updated plan meeting the requirements of OAR Chapter 690, Division 86 (effective November 1, 2002) within 10 years and no later than March 22, 2021.
3. The City of Tigard shall submit a progress report containing the information required under OAR 690-086-0120(4) by September 22, 2016.
