Findings of Fact

Background

- 1. On April 20, 2012, the Department issued an order approving Permit Amendment Application T-10886. The order was recorded at Special Order Volume 87, Pages 400-403.
- 2. The order contains a scrivener's error within the quarter-quarter description of the location of proposed Well 4. The order incorrectly describes the location of Well 4 as:

Twp	Rng	Mer	Sec	Q-Q	Measured Distances
9 S	4 W	WM	10	NE NW	WELL 4 - 250 FEET SOUTH AND 3550 FEET EAST FROM THE SW CORNER OF DLC 40

3. Superseding Permit G-16896 also contains a scrivener's error within the quarter-quarter description of the location of Well 4. The superseding permit incorrectly describes the location of Well 4 as:

Twp	Rng	Mer	Sec	Q-Q	Measured Distances	
9 S	4 W	WM	10	SW NW	WELL 4 - 250 FEET SOUTH AND 3550 FEET EAST FROM THE SW CORNER OF DLC 40	

4. The correct location description of Well 4 is:

Twp	Rng	Mer	Sec	Q-Q	Measured Distances
9 S	4 W	WM	10	SE NW	WELL 4 - 250 FEET SOUTH AND 3550 FEET EAST FROM THE SW CORNER OF DLC 40

This is an order in other than a contested case. This order is subject to judicial review under ORS 183.484. Any petition for judicial review must be filed within the 60-day time period specified by ORS 183.482(2). Pursuant to ORS 536.075 and OAR 137-004-0080, you may petition for judicial review or petition the Director for reconsideration of this order. A petition for reconsideration may be granted or denied by the Director, and if no action is taken within 60 days following the date the petition was filed, the petition shall be deemed denied.

Now, therefore, it is ORDERED:

- The order approving Permit Amendment Application T-10886, recorded at Special Order Volume 87, Pages 400-403 is amended.
- 2. Permit G-16914, in the name of LUCKIAMUTE DOMESTIC WATER COOPERATIVE, is issued to replace Permit G-16896, and incorporates the correction approved by this order. Permit G-16896, in the name of LUCKIAMUTE DOMESTIC WATER COOPERATIVE, is no longer of any force or effect.
- 3. All other terms and conditions of Permit G-16914 remain the same.
- 4. All other provisions of the order recorded at Special Order Volume 87, Pages 400-403 remain unchanged
