## Authority

ORS 540.570 and 540.580 establishes the process in which a district may submit a request to transfer a water right within district boundaries. OAR Chapter 690, Division 385 implements the statutes and provides the Department's procedures and criteria for evaluating district transfer applications.

ORS 540.621 establishes the process for the owner of land to which a water right is appurtenant to certify under oath that the water right, or a portion thereof, has been abandoned and to voluntarily request that it be cancelled.

# **Findings of Fact**

- 1. On December 21, 2015, West Extension Irrigation District filed a district transfer application to permanently change the place of use under Certificates 79924, 79926, 79928 79929, 87872 and 87799. The Department assigned the application number T-12220.
- 2. Notice of the application for transfer was published on December 29, 2015, pursuant to ORS 540.580 and OAR 690-385-4400. No comments were filed in response to the notice.
- 3. The portion of the first right to be transferred is as follows:

Certificate: 79924 in the name of WEST EXTENSION IRRIGATION DISTRICT (confirmed by decree of the Circuit Court of the State of Oregon for Umatilla County. The decree is of record at Salem, in the Order Record of the Water Resources Director in Volume 3 at Pages 213–215.)

Use: IRRIGATION of 15.40 ACRES Priority Date: APRIL 14, 1893

Duty/Rate: Subject to the provisions of Paragraph 33 of Umatilla River Decree

- 14. The District permanent transfer application satisfies the criteria of OAR 690-385-4000, contains the information required under OAR 690-385-2000, and includes maps meeting the requirements of OAR 690-385-2200.
- 15. Water has been used within the last five years according to the terms and conditions of the rights and there is no information in the record that would demonstrate that the rights are subject to forfeiture under ORS 540.610.
- 16. Diversion structures, pumps, canals, pipeline, and sprinkler systems sufficient to use the full amount of water allowed under the existing rights are present.
- 17. The water rights are subject to transfer as defined in OAR 690-385-0100(17).
- 18. The proposed change in place of use would not result in enlargement of the rights.
- 19. The proposed change in place of use will not result in injury to other water rights.

# **Conclusions of Law**

The change in place of use proposed in Transfer Application T-12220 satisfies the requirements of ORS 540.574(3) and 540.580 and the abandoned portion of water rights cited above should be cancelled.

# Now, therefore, it is ORDERED:

- 1. The proposed change to the water right evidenced by Certificates 79924, 79926, 79928, 79929, 87872, and 87799 are approved.
- 2. The right to the use of water is restricted to beneficial use at the place of use described and is subject to all other conditions, limitations contained in water right certificates 79924, 79926, 79928, 79929, 87872, 87799 and any related decree, and the final order approving T-12220.
- 3. The former places of use shall no longer be irrigated as part of these water rights.
- 4. The portion of Certificate 86492 described in Finding of Fact #20 is cancelled. A new right describing the portion of the right not modified (remaining portion) shall be issued.
- 5. The portion of Certificate 86491 described in Finding of Fact #21 is cancelled. A new right describing the portion of the right not modified (remaining portion) shall be issued.
- 6. The water user shall maintain and operate the existing measurement devices and shall make such improvements as may be required by the Department.
- 7. Full beneficial use of the water shall be made, consistent with the terms of this order, on or before October 1, 2017. A Claim of Beneficial Use shall be submitted by the district to the Department within one year after the deadline for completion of the changes andfull beneficial use of the water.
- 8. Water right certificates 79924, 79926, 79928, 79929, 87872, and 87799 are modified. The Department will issue superseding certificates describing the district's rights when it determines that is necessary for record keeping.
