#### **Findings of Fact**

- 1. On February 10, 2015, the Department signed a final order approving Transfer Application T-11950, which was mailed on February 13, 2015, and recorded in Special Order Volume 95, Pages 49, involving Certificates 83571 and 76714.
- 2. The final order approving the transfer contained a scrivener's error in the proposed place of use. The order approved the following parcel as indicated in the table below:

3. Consistent with the proposed place of use table and map submitted with the transfer application for Transfer T-11950, the correct proposed place of use should have been listed in the final order as follows (correction shown in **bold**):

On September 26, 2018, the Department signed a final order making a Determination of Satisfactory Proof for completion of permanent district Transfer T-11950 (DSP order), which was mailed on September 27, 2018. The DSP order was recorded in Special Order Volume 109, Pages 438-440. The DSP order failed to correct the error described in Finding of Fact #2 (corrected in Finding of Fact #3), above.

#### NOTICE OF RIGHT TO PETITION FOR RECONSIDERATION OR JUDICIAL REVIEW

This is an order in other than a contested case. This order is subject to judicial review under ORS 183.482. Any petition for judicial review must be filed within the 60-day time period specified by ORS 183.482. Pursuant to ORS 183.482, ORS 536.075 and OAR 137-003-0675, you may petition for judicial review and petition the Director for reconsideration of this order. A petition for reconsideration may be granted or denied by the Director, and if no action is taken within 60 days following the date the petition was filed, the petition shall be deemed denied.

- 4. This correcting order is being issued to the correct the scrivener's error in the DSP order recorded in Special Order Special Order Volume 109, Pages 438-440.
- 5. Consistent with the final proof map and site report submitted in the Claim of Beneficial use for Transfer T-11950, the place of use for the parcel described in Table 2, Row 10 in the DSP order signed on the September 26, 2018, should be confirmed as follows (correction shown in **bold**):
