Authority

Oregon Administrative Rule (OAR) 690-385-7400 describes the documentation the district must file with the Department in order to provide proof of use.

OAR 690-385-7600 provides in pertinent part that satisfactory proof shall be (a) a determination by the Department that application of water to beneficial use under the terms of the transfer final order was completed to the extent authorized, or (b) a determination by the Department that the application of water to a beneficial use under the terms of the transfer final order was completed to an extent less than authorized.

Oregon Revised Statute (ORS) 540.530(2)(a) and OAR 690-385-7600 authorize the Department to issue or modify a certificate of water right upon satisfactory proof of completion of the change or changes authorized by a final order approving a permanent district transfer.

Findings of Fact

- On March 4, 2014, the Department approved Transfer Application T-11701 for primary irrigation under water right Certificates 74146¹ and 74147. This final order is recorded in Special Order Volume 91 at Pages 916-919. The final order established October 1, 2015, as the date for completion of the authorized changes in place of use.
- 2. On February 1, 2017, the Department signed a correcting final order which was mailed on

- February 9, 2017, to supplement the original final order described in Finding of Fact #1, above. The correcting order is recorded at Special Order Volume 103, Pages 887-893. It was issued to correct the omission of water rights for supplemental irrigation under Certificates 74147, 74148, 74149, and 76520 layered with the approved primary acreage.
- 3. On September 20, 2019, the Department signed a second correcting final order which was mailed on September 23, 2019, to supplement both the original final order and the correcting final order described in Finding of Facts #1 and 2, above. The second correcting order is recorded at Special Order Volume 113, Pages 1248-1251. It was issued to correct the omission of the water right for supplemental irrigation under Certificate 74148 as affected by Special Order Volume 64, Pages 157-158 (place of use formerly described under Certificate 76106), layered with approved primary acreage and other supplemental acreages.
- 4. On February 25, 2016, the Department received a Claim of Beneficial Use (CBU) and associated maps from the applicant for Transfer Application T-11701 satisfying the requirements for providing proof of use under OAR 690-385-7400.
- 5. The Department reviewed the CBU and maps submitted by the applicant for Transfer Application T-11701.
- 6. The CBU did not contain a map of the point of diversion from the source. However, since the transfer involved the transfer of places of use only within an irrigation district and did not involve a change in the point of diversion, the existing maps on file with the Department are sufficient to identify the point of diversion from the source.
- 7. The proposed place of use for Certificate 74146 as approved the final order for Transfer Application T-11701, and as recorded in Special Order Volume 91, Pages 916-919 is shown in Table 1, below:

13. Based on the review of evidence submitted by the applicant, the Department finds that the application of water to beneficial use under the terms of the transfer final order for T-11701 was completed to the extent authorized in the transfer as described in Tables 1, 2, 3, 4, 5, and 6.

Conclusions of Law

- 1. The Applicant has submitted proof of use pursuant to OAR 690-385-7400.
- 2. Application of water to a beneficial use under the terms of the transfer final order has been made to the extent shown in Tables 1, 2, 3, 4, 5, and 6, above.
- 3. The applicant has demonstrated proof of completion under T-11701 to the satisfaction of the Department.
- 4. The Department is authorized to issue or modify certificates of water rights involved in transfer T-11701 consistent with this determination of satisfactory proof of completion.

Now, therefore, it is ORDERED:

Water right Certificates 74146, 74147, 74148, 74149 and 76520 are modified as shown in Tables 1, 2, 3, 4, 5, and 6, above. The Department will issue superseding certificates describing these rights when it determines it is necessary for record keeping.
