Oregon Revised Statutes (ORS) 540.570 to 540.580 establishes the process in which a district may submit a request to transfer a water right within district boundaries. Oregon Administrative Rule (OAR) Chapter 690, Division 385 implements the statutes and provides the Department's procedures and criteria for evaluating district transfer applications.

Findings of Fact

- 1. On June 11, 2014, TUMALO Irrigation District (TID) filed a district transfer application to permanently change the place of use under Certificates 74146, 74147, 74148, 74149, and 76520. The Department assigned the application number T-11834.
- 2. Notice of the District Permanent Transfer Application was published on June 17, 2014, pursuant to ORS 540.580 and OAR 690-385-4400. One comment was filed in response to the notice.
- 3. On February 17, 2020, TID submitted new tables correcting a scrivener's error in a quarter-quarter description and updating water user names.
- 4. The portion of the first right to be transferred is as follows:

Within 20 days after this final order is issued (i.e., mailing date), the district or any protestant may file with the commission exceptions to the final order. The commission shall issue an order granting or denying the exceptions within 30 days after receiving the exceptions. ORS 540.580(10).

- 15. The Department reviewed the one submitted comment (Finding of Fact #2). The Department finds that the proposed district permanent transfer meets all the criteria set forth in ORS 540.580 and OAR 690-385-4000.
- 16. The water right is subject to transfer as defined in OAR 690-385-0100(17).
- 17. Prior to filing district transfer application T-11834 on June 11, 2014, beneficial use of water was made on the authorized place of use in T-11834 under Certificates 74146 and 74147 as evidenced by sequential Instream Leases IL 805 (expired October 1, 2007), IL 916 (expired October 1, 2008), and IL 991 (expired October 1, 2009).
- 18. The proposed change in places of use will not result in enlargement of the right as defined in OAR 690-385-0100(4).
- 19. The proposed change in place of use will not result in injury to other water rights as defined in OAR 690-385-0100(6).
- 20. Any other applicable requirements for district permanent water right transfers are met as required in OAR 690-385-4500.

Conclusions of Law

The proposed changes in place of use as proposed in Transfer Application T-11834 comply with and satisfy the requirements of ORS 540.580 and OAR 690-385-4500.

Now, therefore, it is ORDERED:

- 1. The proposed changes in place of use to the water rights evidenced by Certificates 74146, 74147, 74148, 74149, and 76520 are approved.
- 2. The right to the use of the water is restricted to beneficial use at the place of use not modified by this order and is subject to all other conditions and limitations contained in Certificates 74146, 74147, 74148, 74149, and 76520, and any related decree.

- 3. The proposed changes in place of use as proposed in Transfer Application T-11834 comply with and satisfy the requirements of ORS 540.580 and OAR 690-385-4500.
- 4. The place of use from which the water right is removed by T-11834 shall no longer be irrigated under the transferred rights.
- 5. The water user shall maintain and operate the existing measurement device and shall make such improvements as may be required by the Department.
- 6. Full beneficial use of the water shall be made, consistent with the terms of this order, on or before October 1, 2021. A Claim of Beneficial Use shall be submitted by TID to the Department within one year after the deadline for completion of the changes and full beneficial use of the water.
- 7. Water right Certificates 74146, 74147, 74148, 74149, and 76520 are modified. After satisfactory proof of completion has been determined by the Department, superseding confirming-remaining water right certificates will be issued when the Department determines it is necessary for record keeping.
