Authority

Oregon Revised Statute (ORS) 537.211 establishes the process in which a water right permit holder may submit a request to change the point of appropriation and/or place of use authorized under an existing water right permit.

Findings of Fact

- 1. On September 19, 2019, CITY OF WOODBURN, ATTN: ERIC LILJEQUIST, PUBLIC WORKS DIRECTOR filed an application for additional points of appropriation under Permits G-17730 and G-17731. The Department assigned the application number T-13255.
- 2. On August 12, 2011, the Department approved an extension of time for complete application of water to October 1, 2040, for both permits.
- 3. On August 2, 2019, the Department approved a Water Management and Conservation Plan for both permits, to remain in effect until August 1, 2029.
- 4. Notice of the application for the permit amendment was published in the Department's weekly notice on September 24, 2019, and in the Oregonian newspaper on July 31, and August 7, 2020, pursuant to ORS 540.520(5). No comments were filed in response to the notices.

This is a final order in other than contested case. This order is subject to judicial review under ORS 183.484. Any petition for judicial review must be filed within the 60 day time period specified by ORS 183.484(2). Pursuant to ORS 536.075 and OAR 137-004-0080 and OAR 690-01-0005 you may either petition for judicial review or petition the Director for reconsideration of this order. A petition for reconsideration may be granted or denied by the Director, and if no action is taken within 60 days following the date the petition was filed, the petition shall be deemed denied.

5. Permit Amendment Application T-13255 proposes additional points of appropriation for Permits G-17730 and G-17731 as follows:

Permit Amendment Review Criteria

- 6. The changes would not result in injury to other water rights.
- 7. The changes do not enlarge the permits.
- 8. The changes do not alter any other terms of the permit.

Conclusions of Law

The additional points of appropriation proposed by Permit Amendment Application T-13255 are consistent with the requirements of ORS 537.211.

Now, therefore, it is ORDERED:

- 1. The additional points of appropriation proposed by Permit Amendment Application T-13255 are approved.
- 2. Permit G-18383, in the name of CITY OF WOODBURN, ATTN: ERIC LILJEQUIST, PUBLIC WORKS DIRECTOR, is issued to replace Permit G-17730, and incorporates the amendments approved by this order, the extension of time, and the Water Management and Conservation Plan. Permit G-17730, in the name of CITY OF WOODBURN, RANDY SCOTT, PUBLIC WORKS DIRECTOR is no longer of any force or effect.

- 3. Permit G-18384, in the name of CITY OF WOODBURN, ATTN: ERIC LILJEQUIST, PUBLIC WORKS DIRECTOR, is issued to replace Permit G-177301, and incorporates the amendments approved by this order, the extension of time, and the Water Management and Conservation Plan. Permit G-177301, in the name of CITY OF WOODBURN, RANDY SCOTT, PUBLIC WORKS DIRECTOR is no longer of any force or effect.
- 4. The combined quantity of water diverted at the new additional points of appropriation (New Well Site Option A, B, and C), together with that diverted at the old points of appropriation (Wells 7, 8, 9, 10, 11, 12, 13, and 14), shall not exceed the quantity of water lawfully available at the original points of appropriation (Wells 7, 8, 9, 10, 11, 12, 13, and 14).
- 5. Water shall be acquired from the same aquifer as the original points of appropriation.
- 6. All other terms and conditions of Permits G-18383 and G-18384 remain the same.
