Authority

Oregon Revised Statutes (ORS) 540.570 to 540.580 establish the process in which a district may submit a request to transfer a water right within district boundaries. Oregon Administrative Rule (OAR) Chapter 690, Division 385 implements the statutes and provides the Department's procedures and criteria for evaluating district transfer applications.

Applicant

Findings of Fact

- 1. On April 8, 2022, West Extension Irrigation District (WEID) filed a district transfer application to permanently change the places of use under Certificates 79924, 79925, 94120, 79929, 87872, and 65771. The Department assigned the application number T-13969.
- 2. Notice of the District Permanent Transfer Application was published on April 19, 2022, pursuant to ORS 540.580 and OAR 690-385-4400. No comments were filed in response to the notice.
- 3. The U.S. Bureau of Reclamation was notified of the transfer application on April 19, 2022; no comments were received within 90 days of the notification.
- 4. On February 14, 2023, WEID submitted minor corrections to the tables and a map.
- 5. The portion of the first right to be transferred is as follows:

Certificate: 79924 in the name of WEST EXTENSION IRRIGATION DISTRICT (confirmed by decree of the Circuit Court of the State of Oregon for Umatilla County)

This final order in a contested case and is subject to judicial review by the Court of Appeals under ORS 183.482. Any petition for judicial review must be filed within the 60-day time period specified by ORS 183.482(1). Pursuant to ORS 536.075(2) and OAR 137-003-0675, you may petition for judicial review or petition the Director for reconsideration of this order. A petition for reconsideration may be granted or denied by the Director, and if no action is taken within 60 days following the date the petition was filed, the petition shall be deemed denied.

Within 20 days after this final order is issued (i.e., mailing date), the district or any protestant may file with the commission exceptions to the final order. The commission shall issue an order granting or denying the exceptions within 30 days after receiving the exceptions. ORS 540.580(10).

- 17. The Department finds that the district permanent transfer application was submitted according to ORS 540.580 and OAR 690-385-4000, contains the information required under OARs 690-385-4200 and 690-385-2000, and includes maps meeting the requirements of OARs 690-385-4300 and 690-385-2200.
- 18. The Department finds that the proposed district permanent transfer meets all the criteria set forth in ORS 540.580 and OAR 690-385-4000.
- 19. The water right is subject to transfer as defined in OAR 690-385-0100(17).
- 20. The proposed change in places of use, as conditioned, will not result in enlargement of the right as defined in OAR 690-385-0100(4).
- 21. The proposed change in places of use will not result in injury to other water rights as defined in OAR 690-385-0100(6).
- 22. Any other applicable requirements for district permanent water right transfers are met as required in OAR 690-385-4500.

Partial Cancellation of Water Right Certificate 96925

Portions of water right Certificate 96925 are appurtenant to certain authorized lands involved in T-13969.

23. On December 12, 2023, Herbert Hill, owner of lands to which a portion of Certificate 96925 is appurtenant, submitted an affidavit meeting the requirements of ORS 540.621. The affiant requested a portion of Certificate 96925 be cancelled as it will not be transferred

along with the associated primary. The abandoned portion to be cancelled is described as follows:

Conclusions of Law

The proposed change in places of use as proposed in Transfer Application T-13969 comply with and satisfy the requirements of ORS 540.580 and OAR 690-385-4500, and the abandoned rights should be cancelled.

Now, therefore, it is ORDERED:

- 1. The proposed changes in places of use to the water rights evidenced by Certificates 79924, 79925, 94120, 79929, 87872, and 65771 are approved.
- 2. The places of use from which the water rights are transferred off by Transfer T-13969 shall no longer be irrigated, and are cancelled from Certificates 79924, 79925, 94120, and 79929, 87872.
- 3. Water right Certificate 65771 is cancelled. A new Certificate 97542 will be issued describing that portion of the right not modified by this transfer.
- 4. The portions of the water right as evidenced by Certificates 96925 as requested to be canceled are canceled. A new Certificate 97541 will be issued describing the balance of the right not modified by this Final Order.
- 5. The right to the use of the water at the places of use NOT modified by this order is restricted to beneficial and is subject to all other conditions and limitations contained in Certificates 79924, 79925, 94120, 79929, and 87872, and any related decree.
- 6. The district shall maintain and operate the existing measurement devices on their points of diversion and shall make such improvements as may be required by the Department.
- 7. Water Use Measurement Conditions for the proposed lands transferred under Certificate 65771:
 - a. Before water use may begin under this order, the water user shall install a totalizing flow meter, or, with prior approval of the Director, another suitable measuring device, at each point of diversion (new and existing).
 - b. The water user shall maintain the meters or measuring devices in good working order.

- c. The water user shall allow the Watermaster access to the meters or measuring devices; provided however, where the meters or measuring devices are located within a private structure, the Watermaster shall request access upon reasonable notice.
- 8. Full beneficial use of the water shall be made, consistent with the terms of this order, on or before October 1, 2025. A Claim of Beneficial Use shall be submitted by WEID to the Department within one year after the deadline for completion of the changes and full beneficial use of the water.
- 9. After satisfactory proof of completion has been determined by the Department a new certificate confirming the right transferred under Certificate 65771 will be issued.
- 10. Water right Certificates 79924, 79925, 94120, 79929, and 87872 are modified. After satisfactory proof of completion has been determined by the Department, superseding water right certificates will be issued when the Department determines it is necessary for record keeping.
