**Applicable Law**

ORS 537.455 to 537.500 authorize and establish the process in which a water right holder may submit a request for an allocation of conserved water. OAR Chapter 690, Division 18, implements the statutes and provides the Department's procedures and criteria for evaluating conserved water applications and for implementing the use of the conserved water.

Pursuant to ORS 537.470(3), the Department determined the allocation of conserved water under Conserved Water Application CW-119. Any person or agency allocated conserved water under ORS 537.470 may reserve the water instream for future out-of-stream use or otherwise use or dispose of the conserved water. Any person or agency to whom conserved water is allocated shall notify the Commission of any change in the type of use, place of use, or point of diversion. The notice must be submitted 60 days before the actual the change.

The Director shall approve a change in the type of use, place of use, or point of diversion for conserved water, if: 1) the proposed new use is within the area described under OAR 690-018-0050(4)(h); 2) the proposed change would not constitute an expansion of the right; and c) the approval is consistent with OAR 690-005-0045 (Standards for Goal Compliance and Compatibility with Acknowledged Comprehensive Plans).

**Findings of Fact**

1. On April 15, 2021, an Order of Approval on Completion and Finalization of Allocation of Conserved Water CW-119 (Approval Order) was issued. The Approval Order is recorded at Special Order Volume 120, Pages 166 - 185.

This is an order in other than a contested case. This order is subject to judicial review under ORS 183.484. Any petition for judicial review must be filed within the 60-day time period specified by ORS 183.484(2). Pursuant to ORS 536.075 and OAR 137-004-0080, you may petition for judicial review or petition the Director for reconsideration of this order. A petition for reconsideration may be granted or denied by the Director, and if no action is taken within 60 days following the date the petition was filed, the petition shall be deemed denied.

6. To prevent enlargement of the water rights, the following water use measurement conditions shall apply:
- a. Before the use of the Applicant's portion of conserved water, the water user shall install a totalizing flow meter with telemetry at each point of diversion from the Columbia River. The totalizing flow meter may measure the flow associated with this and other permits using the point of diversion, provided the other water rights from the same point of diversion are identified and reported to the Watermaster. In addition, each user of conserved water under these rights is required to install a totalizing flow meter at each re-diversion point from the common delivery system or other locations as may be required by the Watermaster. The measuring devices need to be approved by the Watermaster prior to installation. The water user shall maintain the required devices in good working order.
  - b. The water user shall allow the Watermaster access to the meters or measuring devices; provided however, where any device is located within a private structure, the Watermaster shall request access upon reasonable notice.
  - c. The Applicant shall also make raw data/information (the rate of flow and total volume of water diverted) from the telemetered measuring devices at the PODs available to the Department in near-real time.


**Conclusions of Law**

1. The proposed use is within the area described under OAR 690-018-0050(4)(h).
2. The proposed use would not constitute an expansion of the rights.
3. The proposed use is consistent with OAR 690-005-0045 (Standards for Goal Compliance and Compatibility with Acknowledged Comprehensive Plans).

**Now, therefore, it is ORDERED:**

1. The use of water as described in Finding of Fact #5 is approved.
2. The use of water for irrigation as described above in Finding of Fact #4, in the Final Orders recorded in Special Order Volume 129, Page 763, Special Order Volume 131, Page 45, and Special Order Volume 134, Page 45 is no longer authorized.
3. The right is subject to the provisions of OAR 690-0018-0090(6) and ORS 540.510 to 540.539, 540.572 to 540.578, and 540.610 to 540.670.
