O R D E R

EXTENDING TIME LIMITS

The above entitled matter now coming on for the consideration of the State Engineer, and it appearing that:

The holders of the following water right permits issued by the State Engineer have submitted applications for extensions of the time limits within which to complete the construction work and/or apply the water to beneficial use under their respective water right permits,

The State Engineer is authorized (Section 116-424, O. C. L. A.) to grant extensions of time for good cause shown, within which to complete work or perfect a right under a water right permit,

It would be impossible with the present personnel to make an examination of the work performed by the following applicants, together with that of all other applicants for extensions of time, and funds are not available for employing additional engineers to make such examinations,

It is urgent that a decision be made upon these applications within a reasonable time in order that the applicants may proceed with the work required in order to apply the waters to be appropriated under the permits to beneficial use,

The State Engineer in this instance is therefore compelled to judge the matter of diligence entirely on the statements contained in the respective applications for extension without an examination of the work performed,

The statements contained in the applications for extension filed by the following indicate that each has shown such reasonable diligence as entitles him to an extension of time, and

No protests or objections to the granting of an extension under any of the following permits have been filed by any subsequent permit holders.

IT IS THEREFORE ORDERED that extensions of time be and the same are hereby granted as follows:
