ORDER APPROVING A CHANGE IN PLACE OF USE AND ADDITIONAL POINTS OF APPROPRIATION

Pursuant to ORS 537.705, after notice was given and no objections were filed, and finding that no injury to existing water rights would result, this order approves, as conditioned or limited herein, TRANSFER 7018 submitted by

MILLER FOREST, INC. P.O. BOX 12395 SALEM, OREGON 97309.

The right to be modified, as evidenced by Certificate 54873, was perfected under Permit G-10009 with a date of priority of JANUARY 3, 1983. The right allows the use of ONE WELL, in the WILLAMETTE RIVER BASIN, for IRRIGATION OF 43.2 ACRES. The amount of water to which this right is entitled is limited to an amount actually beneficially used and shall not exceed 0.54 cubic foot per second, if available at the original well; LOT 2 (NW¼ SW¾), SECTION 21, T 6 S, R 3 W, W.M.; 1940 FEET NORTH AND 1810 FEET WEST FROM THE S¼ CORNER OF SECTION 21, or its equivalent in case of rotation, measured at the well.

The amount of water used for irrigation, together with the amount secured under any other right existing on the same lands, is limited to ONE-EIGHTIETH of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 2½ acre-feet per acre for each acre irrigated during the irrigation season of each year.

The use shall conform to any reasonable rotation system ordered by the proper state officer.

The authorized place of use is as follows:

The right to use water for the above purpose is restricted to beneficial use on the lands or place of use described.

WELL #3 (PERMIT G-2083) - SW½ NW½, SECTION 27, T 6 S, R 3 W, W.M.; 1750 FEET SOUTH AND 20 FEET EAST FROM THE NW CORNER OF DLC 69.

WELL #3 (PERMIT G-7376) - NE¼ NW¼, SECTION 22, T 6 S, R 3 W, W.M.; 1380 FEET NORTH AND 1100 FEET WEST FROM THE CENTER OF SECTION 22.

WELL #3 (GR-368) - NE¼ NE¼, SECTION 28, T 6 S, R 3 W, W.M.; 510 FEET SOUTH AND 1000 FEET WEST FROM THE SW CORNER OF DLC 69.

WELL #5 - NE¼ NW¼, SECTION 27, T 6 S, R 3 W, W.M.; 20 FEET SOUTH AND 1160 FEET WEST FROM THE S¼ CORNER OF SECTION 22.

WELL #6 - SE% SW%, SECTION 22, T 6 S, R 3 W, W.M.; 930 FEET NORTH AND 1140 FEET WEST FROM THE S% CORNER OF SECTION 22.

OREY WELL - NW¼ SW¼, SECTION 27, T 6 S, R 3 W, W.M.; 1500 FEET NORTH AND 700 FEET EAST FROM THE SW CORNER OF DLC 69.

THIS CHANGE TO AN EXISTING WATER RIGHT MAY BE MADE PROVIDED THE FOLLOWING CONDITIONS ARE MET BY THE WATER USER:

- 1. The proposed change shall be completed on or before October 1, 1999.
- 2. The quantity of water diverted at the new points of appropriation (well), together with the quantity diverted at the old points of appropriation, shall not exceed the quantity of water lawfully available from the original points of appropriation.
- 3. When required by the Department the water user shall install in-line flow meters or other suitable devices for measuring and recording the quantity of water used. The type and plans of the measuring devices must be approved by the Department prior to beginning construction and shall be installed under the general supervision of the Department.
- 4. Water shall be acquired from the same aquifer as the original point of appropriation.
- 5. The former place of use shall no longer be irrigated as part of this water right.

Certificate 54873 is cancelled. When satisfactory proof of the completed change is received, a new certificate confirming this water right will be issued.
