## ORDER APPROVING A CHANGE IN PLACE OF USE

Pursuant to ORS 540.510 to 540.530, after notice was given and no objections were filed, and finding that no injury to existing water rights would result, this order approves, as conditioned or limited herein, TRANSFER 8554 submitted by

JACK CLUBB 1900 N.W. CARDEN AVENUE PENDLETON, OREGON 97801.

The right to be modified was confirmed by decree of the Circuit Court of the State of Oregon for UMATILLA County as evidenced by a PORTION of Certificate 29165. The decree is recorded in the Order Record of the Water Resources Director in Volume 3, at Page 127. The date of priority is 1895.

The right allows the use of the UMATILLA RIVER, a tributary of the COLUMBIA RIVER, for IRRIGATION OF 4.6 ACRES. The amount of water to which this right is entitled is limited to an amount actually beneficially used and shall not exceed 0.056 cubic foot per second, if available at the authorized point of diversion: NE% NE%, SECTION 12, T 2 N, R 32 E, W.M.; NORTH 7 DEGREES 2

This is an order in other than a contested case. This order is subject to judicial review under ORS 183.484. Any petition for judicial review must be filed within the 60 day time period specified by ORS 183.484(2).

Pursuant to ORS 536.075 and OAR 137-004-080 and OAR 690-01-005 you may either petition for judicial review or petition the Director for reconsideration of this order.

MINUTES 20 SECONDS WEST 1801 FEET FROM THE W% CORNER, SECTION 7, T 2 N, R 33 E, W.M., or its equivalent in case of rotation, measured at the point of diversion from the source.

The authorized place of use is located as follows:

NW% NE% 4.6 ACRES

SECTION 12

TOWNSHIP 2 NORTH, RANGE 32 EAST, W.M.

The right to use water for the above purpose is restricted to beneficial use on the lands or place of use described and is subject to the provisions of paragraph 33 of said decree and all other conditions and limitations contained in said decree.

The applicant proposes to change the place of use:

NE% NE% 4.6 ACRES
SECTION 12
TOWNSHIP 2 NORTH, RANGE 32 EAST, W.M.

THIS CHANGE TO AN EXISTING WATER RIGHT MAY BE MADE PROVIDED THE FOLLOWING CONDITIONS ARE MET BY THE WATER USER:

- 1. The proposed change shall be completed on or before October 1, 2002.
- 2. When required by the Department, the water user shall install and maintain a headgate, an in-line flow meter, weir, or other suitable device for measuring and recording the quantity of water diverted. The type and plans of the headgate and measuring device must be approved by the Department prior to beginning construction and shall be installed under the general supervision of the Department.
- 3. The former place of use shall no longer be irrigated as a part of this water right.

Certificate 29165 is canceled. A new certificate will be issued to confirm that portion of the right NOT involved in this transfer. When satisfactory proof of the completed change is received, a new certificate confirming this water right will be issued.
