ORDER APPROVING A CHANGE IN PLACE OF USE IN AN IRRIGATION DISTRICT

Pursuant to ORS 540.580, after notice was given and no objections were filed, and finding that no injury to existing water rights would result, this order approves a change in place of use of water within a district as conditioned or limited herein, TRANSFER 8981 submitted by

TUMALO IRRIGATION DISTRICT 64697 COOK AVENUE BEND, OREGON 97701.

The first right to be modified was confirmed by decree of the Circuit Court of the State of Oregon for Deschutes County as evidenced by portions of Certificate 74146. The decree is recorded in the Order Record of the Water Resources Director in Volume 1, at Page 135. The dates of priority are September 1, 1900, and June 1, 1907.

The right allows the use of Tumalo Creek, a tributary of The Deschutes River, for irrigation of 19.91 acres.

Also to be modified are supplemental rights evidenced by portions of Certificates 74147, 74148, 74149 and 76520. These rights are supplemental to the same lands or places of use authorized by Certificate 74146, and are to transfer to the same proposed places of use.

Except as modified herein, all conditions and restrictions of Certificates 74146, 74147, 74148, 74149, 76106 and 76520 remain in effect.

When the Director determines that it is necessary, or to facilitate records keeping, new certificates will be issued to confirm all completed changes for which satisfactory proof has been made and to confirm those portions not modified by this or any other order.
