Findings of Fact

- 1. On June 16, 2005, Roats Water System, Inc. filed an application to transfer the point of appropriation, place of use and character of use under Certificates 81657 and 81672. The Department assigned the application number T-9955.
- 2. The applicant amended Transfer Application T-9955 on January 5, 2007, to remove the proposed place of use and character of use changes for the supplemental irrigation portion of Certificate 81657.
- 3. The FIRST right to be transferred is as follows:

- 9. Notice of the application for transfer was published on July 5, 2005, pursuant to ORS 540.520 and OAR 690-380-4000. No comments were filed in response to the notice.
- 10. On February 27, 2007, the Department issued a preliminary determination proposing to approve Transfer Application T-9955 and mailed a copy to the applicant. Additionally, notice of the preliminary determination for the transfer application was published in the Department's weekly notice on March 6, 2007, and in a local newspaper on March 16, 23, and 30, 2007, pursuant to ORS 540.520 and OAR 690-380-4020. No protests were filed in response to the Department's weekly notice or to the newspaper notice.
- 11. Water has been used within the last five years according to the terms and conditions of the rights, and no evidence is available that would demonstrate that the rights are subject to forfeiture under ORS 540.610.
- 12. A pump, pipeline, and distribution system sufficient to use the full amount of water allowed under the existing right is present.
- 13. The proposed changes, as conditioned, would not result in enlargement of the rights.
- 14. The proposed changes, as conditioned, would not result in injury to other water rights.

Conclusions of Law

The changes in point of appropriation, place of use and character of use proposed in Transfer Application T-9955, as conditioned, are consistent with the requirements of ORS 537.705, 540.505 to 540.580, and OAR 690-380-5000.

Now, therefore, it is ORDERED:

- 1. The changes in point of appropriation, place of use and character of use in Transfer Application T-9955 are approved.
- 2. The right to use of the water is restricted to beneficial use at the place of use described, and is subject to all other conditions and limitations contained in Certificates 81657 and 81672 and any related decree.
- 3. Water Right Certificates 81657 and 81672 are cancelled.
- 4. Water shall be acquired from the same aquifer (water source) as the original point of appropriation.

- 5. The approved changes shall be completed and full beneficial use of the water shall be made on or before **October 1, 2008.** A Claim of Beneficial Use prepared by a Certified Water Rights Examiner shall be submitted by the applicant to the Department within one year after the deadline for completion of the changes and full beneficial use of the water.
- 6. The quantity of water diverted at the new point of appropriation shall not exceed the quantity of water lawfully available at the original points of appropriation.
- 7. The former place of use from which water has been transferred shall no longer receive water as part of these rights.
- 8. The use of the irrigation portion under Certificate 81672 for quasi-municipal use shall be allowed during the time period April 1 to November 1 of each year (irrigation season) and shall be limited to a rate of diversion of 0.06 cubic foot per second, being further limited to no more than 18.0 acre feet of water annually.
- 9. The use of the group domestic portion under Certificate 81672 for quasi-municipal use shall be allowed year round and shall be limited to a rate of diversion of 0.5 cubic foot per second, being further limited to no more than 181.0 acre feet of water annually.
- 10. The use of the group domestic portion under Certificate 81657 for quasi-municipal use shall be allowed year round and shall be limited to a rate of diversion of 0.5 cubic foot per second, being further limited to no more than 181.0 acre feet of water annually.
- 11. Prior to diverting water at the new point of appropriation, the water user shall install and maintain an in-line flow meter or other suitable device for measuring and recording the quantity of water appropriated. The type and plans of the measuring device must be approved by the Department prior to beginning construction and shall be installed under the general supervision of the Department.
- 12. When satisfactory proof of the completed changes is received, new certificates confirming the rights transferred will be issued.
