Authority

ORS 536.750 establishes the process in which a water right holder may submit a request to temporarily transfer the use, place of use or point of diversion of water in the event of a declaration of drought, without complying with the notice and waiting requirements under ORS 540.520. OAR Chapter 690, Division 019 implements the statutes and provides the Department's procedures and criteria for evaluating drought transfer applications.

Applicant

KNOLL RANCH LLC 5429 REEDER RD KLAMATH FALLS, OR 97603

Findings of Fact

- 1. On June 25, 2014, KNOLL RANCH LLC filed an application to temporarily change the place of use and point of diversion for a portion of Claim KA-1000 for the remainder of the 2014 irrigation season or the term of the Governor's declared drought, whichever is shorter. The Department assigned the application number T-11853.
- 2. The applicant has provided consent by deeded landowner of the "from" lands.
- 3. The applicant has indicated that portions of Water Right Certificate 67133 (Application S-55994) and T-11266 are located on portions of the "to" lands. In addition, the Department has found that Water Right Certificate 65658 overlies a portion of the "from" lands.
- 4. Notice of the application for transfer was published on July 1, 2014 pursuant to OAR 690-380-4000. No comments were filed in response to the notice.
- 5. The portion of the claim to be temporarily transferred is as follows:

Claim: KA 1000 in the names of DON BUFFINGTON: WINEMA HUNTING

Use:

IRRIGATION OF 383.5 ACRES

Priority Date: MAY 19, 1905

Temporary Transfer Review Criteria

- 8. A pump, pipeline, and sprinkler system sufficient to use the full amount of water allowed under the existing claim is present.
- 9. The Governor issued an executive order on February 13, 2014, declaring a state of drought emergency in Klamath County due to drought and extreme weather conditions, which is still in effect and the water right proposed for transfer is on lands included in the area covered by the drought order.
- 10. The proposed changes would not result in enlargement of the claims.
- 11. The proposed changes would not result in injury to other water rights. This finding is made through an abbreviated review recognizing that the transfer may be revoked under OAR 690-019-055(3) if injury to existing water rights is shown and cannot be mitigated to the satisfaction of the Director and injured parties.

Conclusions of Law

The temporary change in place of use proposed in Temporary Drought Transfer Application T-11853 is consistent with the requirements of ORS 536.750 and OAR 690-019-0055.

Now, therefore, it is ORDERED:

- 1. The temporary changes in place of use and point of diversion proposed in Temporary Drought Transfer Application T-11853 are approved.
- 2. The former place of use **shall not** be irrigated during the remainder of the 2014 irrigation season or until the end of the Governor's declared drought, whichever occurs first.
- 3. The portions of Water Right Certificate 65658 located on the "from" lands and Certificate 67133 and T-11266 located on the "to" lands shall not be exercised during the duration of this transfer.

- 4. Water use measurement conditions:
 - a. **Before water use may begin** under this order, the water user shall install a totalizing flow meter, or, with prior approval of the Director, another suitable measuring device, at each point of diversion (new and existing)
 - b. The water user shall maintain the meters or measuring devices in good working order.
 - c. The water user shall allow the Watermaster access to the meters or measuring devices; provided however, where the meters or measuring devices are located within a private structure, the Watermaster shall request access upon reasonable notice.
- 5. The approval of this temporary drought transfer may be revoked or modified if the Department finds the changes cause injury to any existing water right.
- 6. The use of water at the temporary places of use authorized by this transfer shall be in accordance with the terms and conditions of KA-1000.
- 7. The approval of this temporary transfer may be revoked or modified if the Department finds the change causes injury to any existing water right.
- 8. The proposed change in place of use shall revert to the authorized place of use at the end of the 2014 irrigation season or the end of the Governor's declared drought, whichever occurs first.
- 9. The proposed change in point of diversion shall revert to the authorized point of diversion at the end of the 2014 irrigation season or the end of the Governor's declared drought, whichever occurs first.
- 10. The use of the remaining claim described by KA-1000 shall continue to be in accordance with the terms and conditions of Claim KA-1000.
