A petition for reconsideration may be granted or denied by the Director, and if no action is taken within 60 days following the date the petition was filed, the petition shall be deemed denied.

Application History

Permit G-9912 was issued by the Department on November 23, 1982. The permit called for completion of construction by October 1, 1984, and complete application of water to beneficial use by October 1, 1985. The most recent extension authorized completion of construction and complete application of water to beneficial use by October 1, 1990. On July 10, 2013, the City of Final Order: Permit G-9912

Adrian submitted an application to the Department for an extension of time for Permit G-9912. In accordance with OAR 690-315-0050(2), on May 12, 2015, the Department issued a Proposed Final Order proposing to extend the time to complete construction to October 1, 2052 and to extend the time to fully apply water to beneficial use to October 1, 2052. The protest period closed June 26, 2015, in accordance with OAR 690-315-0060(1). No protest was filed.

FINDINGS OF FACT

The Department adopts and incorporates by reference the findings of fact in the Proposed Final Order dated May 12, 2015.

At time of issuance of the Proposed Final Order the Department concluded that, based on the factors demonstrated by the applicant, the permit may be extended subject to the following conditions:

CONDITIONS

1. Development Limitations

Appropriation of any water beyond 0.61 cfs up to 0.91 cfs, being any water from Well 1, and no more than 0.12 cfs from Wells 2, 0.05 cfs from Well 3, and 0.44 cfs from Well 4, under Permit G-9912 shall only be authorized upon issuance of a final order approving a Water Management and Conservation Plan (WMCP) under OAR Chapter 690, Division 86 that authorizes access to a greater rate of appropriation of water under the permit consistent with OAR 690-086-0130(7). The required WMCP shall be submitted to the Department within 3 years of this Final Order. The amount of water used under Permit G-9912 must be consistent with this and subsequent WMCP's approved under OAR Chapter 690, Division 86 on file with the Department.

The deadline established in this Extension Final Order for submittal of a WMCP shall not relieve a permit holder of any existing or future requirement for submittal of a WMCP at an earlier date as established through other orders of the Department. A WMCP submitted to meet the requirements of this final order may also meet the WMCP submittal requirements of other Department orders.

CONCLUSION OF LAW

The applicant has demonstrated good cause for the permit extension pursuant to ORS 537.630, 539.010(5) and OAR 690-315-0080(3).

ORDER

The extension of time for Application G-10619, Permit G-9912, therefore, is approved subject to conditions contained herein. The deadline for completing construction is extended from October 1, 1990 to October 1, 2052. The deadline for applying water to full beneficial use within the terms and conditions of the permit is extended from October 1, 1990 to October 1, 2052.
