PERMIT TO APPROPRIATE THE PUBLIC WATERS

This is to certify that I have examined APPLICATION G-9047 and do hereby grant the same SUBJECT TO EXISTING RIGHTS and the following limitations and conditions:

This permit is issued to Pierre and Elizabeth Jones of Star Route West, Mt. Vernon, Oregon 97865, phone 932-4488 for use of the waters from three wells and one infiltration gallery

for the PURPOSE of supplemental irrigation. The use allowed herein may be made at any time during the year that water can be put to beneficial use by irrigation, either for immediate crop growth or for forcast requirements to raise the soil moisture to field capacity in the soil profile * that the PRIORITY OF THE RIGHT dates from December 8, 1978

and is limited to the amount of water which can be applied to beneficial use and shall not exceed 1400 gallons per minute of water

measured at the point of diversion from the wells , or its equivalent in case of rotation with other water users.

The well is to be LOCATED: Diversion Point Well 1 - 130 feet East and 1750 feet North from the SW Corner, Section 21, being within the NW 1/4 SW 1/4, Section 21; Diversion Point Well 2 feet West and 1580 feet North from the SE Corner, Section 20, being within the NE 1/4 SE 1/4 of Section 20; Diversion Point Well 3 - 945 feet West and 1580 feet North from the SE Corner, **

A description of the PLACE OF USE under the permit, and to which such right is appurtenant, is as follows:

- * to be utilized by plant growth in the subsequent growing season.
- ** Section 20, being within the NE 1/4 SE 1/4 of Section 20; and Diversion Point of Infiltration Gallery 100 feet North and 3260 feet West from the SE Corner of Section 20, being within the SE 1/4 SW 1/4 of Section 20, all in Township 13 South, Range 30 East, WM, in the County of Grant.

The well shall be constructed in accordance with the General Standards for the Construction and Maintenance of Water Wells in Oregon. The works constructed shall include an air line and pressure gauge or an access port for measuring line, adequate to determine water level elevation in the well at all times. The permittee shall install and maintain a weir, meter, or other suitable measuring device, and shall keep a complete record of the amount of ground water withdrawn.

Actual construction work shall begin on or before June 13, 1984, and shall thereafter be prosecuted with reasonable diligence and be completed on or before October 1, 1984. Extended to October 1, 1988

Complete application of the water to the proposed use shall be made on or before October 1, 1985 . Extended to October 1, 1988

The AMOUNT OF WATER used for irrigation, together with the amount secured under any other right existing for the same lands shall be limited to 1/80 of one cubic foot per second per acre, and shall be further limited to a diversion of not to exceed 3.0 acre-feet per acre for each acre irrigated during the irrigation season of each year, and shall be further limited to a diversion of not to exceed 1.0 acre-foot per acre irrigated during the period from October 1 to March 31, provided further that the right allowed herein together with the amount secured under any other right existing for the same land shall not exceed 3.0 acre-feet for each acre irrigated in any one year, and shall form to such reasonable rotation system as may be ordered by the proper state officer.
