PERMIT TO APPROPRIATE THE PUBLIC WATERS

This is to certify that I have examined APPLICATION $\,G\text{--}10924\,$ and do hereby grant the same SUBJECT TO EXISTING RIGHTS and the following limitations and conditions:

This permit is issued to Holland Brothers, a co-partnership of Raymond W. and George A. Holland of 89899 North Game Farm Road, Eugene, Oregon 97401, phone 345-0035 for use of the waters of one well

for the PURPOSE of irrigation

that the PRIORITY OF THE RIGHT dates from April 12, 1983

and is limited to the amount of water which can be applied to beneficial use and shall not exceed 0.88 cubic foot per second of water

measured at the point of diversion from the well , or its equivalent in case of rotation with other water users.

The well is to be LOCATED: 1311.2 feet South and 126 feet West from the Center of Section 7, being within the NE 1/4 SW 1/4 of Section 7, Township 15 South, Range 4 West, WM, in the County of Lane.

A description of the PLACE OF USE under the permit, and to which such right is appurtenant, is as follows:

Township 15 South, Range 4 West, WM Section 7 SE 1/4 SW 1/4 21.2 acres NE 1/4 SW 1/4 19.2 acres SW 1/4 SE 1/4 17.0 acres NW 1/4 SE 1/4 13.0 acres

The AMOUNT OF WATER used for irrigation, together with the amount secured under any other right existing for the same lands shall be limited to 1/80 of one cubic foot per second per acre, and shall be further limited to a diversion of not to exceed 2.5 acre-feet per acre for each acre irrigated during the irrigation season of each year, and shall conform to such reasonable rotation system as may be ordered by the proper state officer.

The well shall be constructed in accordance with the General Standards for the Construction and Maintenance of Water Wells in Oregon. The works constructed shall include an air line and pressure gauge or an access port for measuring line, adequate to determine water level elevation in the well at all times. The permittee shall install and maintain a weir, meter, or other suitable measuring device, and shall keep a complete record of the amount of ground water withdrawn.

Actual construction work shall begin on or before July 15, 1984 , and shall thereafter be prosecuted with reasonable diligence and be completed on or before October 1, 19 84.

Complete application of the water to the proposed use shall be made on or before October 1, 19 85 .
