PERMIT TO APPROPRIATE THE PUBLIC WATERS

This is to certify that I have examined APPLICATION **G-10699** and do hereby grant the same SUBJECT TO EXISTING RIGHTS and the following limitations and conditions:

This permit is issued to **Edwin J. and Patricia A. Vieira of Star Route, Box 6, Beatty, Oregon 97621, phone 533-2541 or 533-2655** for use of the waters from a well,

for the PURPOSE of **irrigation**

that the PRIORITY OF THE RIGHT dates from **April 28, 1982**

and is limited to the amount of water which can be applied to beneficial use and shall not exceed **0.49 cubic foot per second**

measured at the point of diversion from the **well**, or its equivalent in case of rotation with other water users.

The well is to be LOCATED: **13 feet South and 360 East from the Center Corner of Section 23, being within the NW 1/4 SE 1/4 of Section 23, Township 36 South, Range 11 East, WM, in the County of Klamath.**

A description of the PLACE OF USE under the permit, and to which such right is appurtenant, is as follows:

Township 36 South, Range 11 East, WM	Section 23	NE 1/4	SE 1/4	21.5 acres
		SW 1/4	SE 1/4	18.0 acres

The AMOUNT OF WATER used for irrigation, together with the amount secured under any other right existing for the same lands shall be limited to 1/80 of one cubic foot per second per acre, and shall be further limited to a diversion of not to exceed 3.0 acre-feet per acre for each acre irrigated during the irrigation season of each year; provided further that in the event of a request for a change in point of appropriation, an additional point of appropriation or repair of this well, the quantity of water allowed herein together with any other right from this point of appropriation shall not exceed the capacity of this well at the time of perfection of this right, provided further that the right herein granted shall be subject to prior rights to appropriate ground water from the ground water reservoir which serves as the source of the appropriation authorized herein, provided further that should it be determined subsequent to the issuance of this permit that the appropriation of ground water herein authorized has a measureable effect on the flow of Whiskey Creek and/or its tributaries, the appropriation of ground water herein authorized shall be regulated in accord with prior rights to appropriate such surface water flows.

The well shall be constructed in accordance with the General Standards for the Construction and Maintenance of Water Wells in Oregon. The works constructed shall include an air line and pressure gauge or an access port for measuring line, adequate to determine water level elevation in the well at all times. The permittee shall install and maintain a weir, meter, or other suitable measuring device, and shall keep a complete record of the amount of ground water withdrawn.

Actual construction work shall begin on or before **August 11, 1984**, and shall thereafter be prosecuted with reasonable diligence and be completed on or before October 1, 19 ⁸⁴.

Complete application of the water to the proposed use shall be made on or before October 1, 19 ⁸⁵.
