This is to certify that I have examined APPLICATION G-10908 and do hereby grant the same SUBJECT TO EXISTING RIGHTS and the following limitations and conditions:

This permit is issued to Leonard A. Lorensen, Lorensen Ranches, Incorporated of Star Route, Box 810, Pendleton, Oregon 97801, phone 276-6108 for use of the waters from a well,

for the PURPOSE of irrigation.

that the PRIORITY OF THE RIGHT dates from March 28, 1983

and is limited to the amount of water which can be applied to beneficial use and shall not exceed 8.07 cubic feet per second of water

measured at the point of diversion from the well , or its equivalent in case of rotation with other water users.

The well is to be LOCATED: 1860 feet South and 2920 feet East from the W 1/4 Corner of the Section 35, being within the SW 1/4 SE 1/4 of Section 35, Township 4 North, Range 30 East, WM, in the County of Umatilla.

The AMOUNT OF WATER used for irrigation, together with the amount secured under any other right existing for the same lands shall be limited to 1/80 of one cubic foot per second per acre, and shall be further limited to a diversion of not to exceed <u>3.0</u> acre-feet per acre for each acre irrigated during the irrigation season of each year, and shall conform to such reasonable rotation system as may be ordered by the proper state officer.

The well shall be constructed in accordance with the General Standards for the Construction and Maintenance of Water Wells in Oregon The works constructed shall include an air line and pressure gauge or an access port for measuring line, adequate to determine water level elevation in the well at all times. The permittee shall install and maintain a weir, meter, or other suitable measuring device, and shall keep a complete record of the amount of ground water withdrawn.
