PERMIT TO APPROPRIATE THE PUBLIC WATERS

This is to certify that I have examined APPLICATION **G-10872** and do hereby grant the same SUBJECT TO EXISTING RIGHTS and the following limitations and conditions:

This permit is issued to **Darlene Henny of 7811 Stratford Drive, NE, Brooks, Oregon 97305, phone 792-3376, for use of the waters from three wells, being 1.67 cubic foot per second from each well provided the total diverted shall not exceed 1.67 cfs** for the PURPOSE of **irrigation and temperature control, being 0.14 cfs for irrigation and 1.67 cfs for temperature control provided the total diverted shall not exceed 1.67 cfs maximum**

that the PRIORITY OF THE RIGHT dates from **January 27, 1983**

and is limited to the amount of water which can be applied to beneficial use and shall not exceed **1.67 cfs**

measured at the point of diversion from the **wells**, or its equivalent in case of rotation with other water users.

The well is to be LOCATED: **Well 1 - 1180 feet South and 360 feet East; Well 2 - 960 feet South and 414 feet East, both from the Reentrant Corner on the West line of DLC 57, being within the NE 1/4 SW 1/4 of Section 11; Well 3 - 2640 feet South and 430 feet East from the Reentrant Corner on the West line of DLC 57, being within the SE 1/4 SW 1/4 of Section 11; all within ***

A description of the PLACE OF USE under the permit, and to which such right is appurtenant, is as follows:

* **Township 6 South, Range 2 West, WM, in the County of Marion.**

Township 6 South, Range 2 West, WM Section 11 SE 1/4 SW 1/4 11.1 acres irrigation and temperature control

The AMOUNT OF WATER used for irrigation, together with the amount secured under any other right existing for the same lands shall be limited to 1/80 of one cubic foot per second per acre, and shall be further limited to a diversion of not to exceed 2.5 acre-feet per acre for each acre irrigated during the irrigation season of each year, provided further that in the event of a request for a change in point of appropriation, an additional point of appropriation or repair of this well, the quantity of water allowed herein together with any other right from this point of appropriation shall not exceed the capacity of this well at the time of perfection of this right, and shall conform to such reasonable rotation system as may be ordered by the proper state officer.

The well shall be constructed in accordance with the General Standards for the Construction and Maintenance of Water Wells in Oregon. The works constructed shall include an air line and pressure gauge or an access port for measuring line, adequate to determine water level elevation in the well at all times. The permittee shall install and maintain a weir, meter, or other suitable measuring device, and shall keep a complete record of the amount of ground water withdrawn.

Actual construction work shall begin on or before **September 20, 1984**, and shall thereafter be prosecuted with reasonable diligence and be completed on or before **October 1, 1984**.

Complete application of the water to the proposed use shall be made on or before **October 1, 1985**.
