PERMIT TO APPROPRIATE THE PUBLIC WATERS

This is to certify that I have examined APPLICATION **G-10876** and do hereby grant the same SUBJECT TO EXISTING RIGHTS and the following limitations and conditions:

This permit is issued to **Ridgewood District Improvement Company of 7890 Northwest Ridgewood Drive, Corvallis, Oregon 97330, phone 757-7047, for use of the waters from a well**

for the PURPOSE of **domestic use for two families and irrigation, being 0.27 cubic foot per second for irrigation and 0.01 cfs for domestic use for two families**

that the PRIORITY OF THE RIGHT dates from **February 8, 1983 for 0.26 cfs and March 31, 1983 for 0.02 cfs**

and is limited to the amount of water which can be applied to beneficial use and shall not exceed **0.28 cfs**

measured at the point of diversion from the **well**, or its equivalent in case of rotation with other water users.

The well is to be LOCATED: **50 feet South and 440 feet West from the Northeast Corner of Section 31, being within the NE 1/4 NE 1/4 of Section 31, Township 11 South, Range 5 West, WM, in the County of Benton.**

A description of the PLACE OF USE under the permit, and to which such right is appurtenant, is as follows:

The AMOUNT OF WATER used for irrigation, together with the amount secured under any other right existing for the same lands shall be limited to 1/80 of one cubic foot per second per acre, and shall be further limited to a diversion of not to exceed 2.5 acre-feet per acre for each acre irrigated during the irrigation season of each year, and shall conform to such reasonable rotation system as may be ordered by the proper state officer.

The well shall be constructed in accordance with the General Standards for the Construction and Maintenance of Water Wells in Oregon. The works constructed shall include an air line and pressure gauge or an access port for measuring line, adequate to determine water level elevation in the well at all times. The permittee shall install and maintain a weir, meter, or other suitable measuring device, and shall keep a complete record of the amount of ground water withdrawn.

Actual construction work shall begin on or before **September 20, 1984**, and shall thereafter be prosecuted with reasonable diligence and be completed on or before **October 1, 1984**.

Complete application of the water to the proposed use shall be made on or before **October 1, 1985**.
