PERMIT TO APPROPRIATE THE PUBLIC WATERS

This is to certify that I have examined APPLICATION G-10510 and do hereby grant the same SUBJECT TO EXISTING RIGHTS and the following limitations and conditions:

This permit is issued to Nevin Cattle Company of Star Route, Dairy, Oregon 97625, phone 882-1194, for use of the waters from Deer Ridge Well, Liskey Well and Mitchell Well, being 0.82 cubic foot per second from Deer Ridge Well; 0.09 cfs from Liskey Well and 0.07 cfs from Mitchell Well for the PURPOSE of irrigation

that the PRIORITY OF THE RIGHT dates from August 31, 1982

and is limited to the amount of water which can be applied to beneficial use and shall not exceed 0.98 cfs

measured at the point of diversion from the wells , or its equivalent in case of rotation with other water users.

The well is to be LOCATED: Deer Ridge Well - 2840 feet North and 80 feet East from the Southwest Corner of Section 24, being within SW 1/4 NW 1/4 of Section 24; Liskey Well - 800 feet South and 430 feet East from the Northwest Corner of Section 13, being within the NW 1/4 NW 1/4 of Section 13, both being within Township 38 South, Range 10 East, WM; Mitchell Well - 780 feet A description of the PLACE OF USE under the permit, and to which such right is appurtenant, is as follows:

* North and 6 feet East from the Southeast Corner of Section 24, Township 38 South, Range 10, WM, being within Lot 3 (NW 1/4 SW 1/4) of Section 30, Township 38 South, Range 11 1/2 East, WM; in the County of Klamath

The AMOUNT OF WATER used for irrigation, together with the amount secured under any other right existing for the same lands shall be limited to 1/80 of one cubic foot per second per acre, and shall be further limited to a diversion of not to exceed 3.0 acre-feet per acre for each acre irrigated during the irrigation season of each year, and shall conform to such reasonable rotation system as may be ordered by the proper state officer.

The well shall be constructed in accordance with the General Standards for the Construction and Maintenance of Water Wells in Oregon. The works constructed shall include an air line and pressure gauge or an access port for measuring line, adequate to determine water level elevation in the well at all times. The permittee shall install and maintain a weir, meter, or other suitable measuring device, and shall keep a complete record of the amount of ground water withdrawn.

Actual construction work shall begin on or before November 8, 1984, and shall thereafter be prosecuted with reasonable diligence and be completed on or before October 1, 1985.

Complete application of the water to the proposed use shall be made on or before October 1, 19 86 .
