PERMIT TO APPROPRIATE "CERTIFICATE NO. ______

This is to certify that I have examined APPLICATION G-10344 and do hereby grant the same SUBJECT TO EXISTING RIGHTS and the following limitations and conditions:

This permit is issued to Harold Kraemer of 13318 Domnic Road, Mt. Angel, Oregon 97362, phone 845-2489, for use of the waters from two wells, being 0.85 cubic feet per second of water from Well 1 and 0.66 cfs from Well 2

for the PURPOSE of

supplemental irrigation

that the PRIORITY OF THE RIGHT dates from September 20, 1983

and is limited to the amount of water which can be applied to beneficial use and shall not exceed 1.51 cubic feet per second

measured at the point of diversion from the wells , or its equivalent in case of rotation with other water users.

The well is to be LOCATED: Well I - 1110 feet South and 80 feet East from the Northwest Corner of Section 17, being within the NW I/4 NW I/4 of Section 17; Well 2 - 1425 feet South and 2075 feet East from the Northwest Corner of Section 17, being within the SE I/4 NW I/4 of Section 17, both within Township 6 South, Range 1 East, WM, in the County of Marion.

A description of the PLACE OF USE under the permit, and to which such right is appurtenant, is as follows:

Township 6 South, Range I East, WM Section 6 SW 1/4 SW 1/4 38.0 acres
Section 7 NE 1/4 NW 1/4 10.2 acres
NW 1/4 NW 1/4 37.6 acres
SW 1/4 NW 1/4 35.1 acres

The AMOUNT OF WATER used for irrigation, together with the amount secured under any other right existing for the same lands shall be limited to 1/80 of one cubic foot per second per acre, and shall be further limited to a diversion of not to exceed 2.5 acre-feet per acre for each acre irrigated during the irrigation season of each year, provided further that the right allowed herein shall be limited to any deficiency in the available supply of any prior right existing for the same land and shall not exceed the limitation allowed herein, and shall conform to such reasonable rotation system as may be ordered by the proper state officer.

The well shall be constructed in accordance with the General Standards for the Construction and Maintenance of Water Wells in Oregon. The works constructed shall include an air line and pressure gauge or an access port for measuring line, adequate to determine water level elevation in the well at all times. The permittee shall install and maintain a weir, meter, or other suitable measuring device, and shall keep a complete record of the amount of ground water withdrawn.

Actual construction work shall begin on or before November 17, 1984, and shall thereafter be prosecuted with reasonable diligence and be completed on or before October 1, 1985.

Complete application of the water to the proposed use shall be made on or before October 1, 19 86.
