## PERMIT TO APPROPRIATE THE PUBLIC WATERS

This is to certify that I have examined APPLICATION **G-11034** and do hereby grant the same SUBJECT TO EXISTING RIGHTS and the following limitations and conditions:

This permit is issued to **Stephen Frederick Counts of 619 West Jones Creek Road, Grants Pass, Oregon 97526, phone 476-4067, for use of the waters from a well and a sump, being 0.066 cubic foot per second of water from the well with any deficiency in the available supply of water from\*** for the PURPOSE of **irrigation**

that the PRIORITY OF THE RIGHT dates from **July 25, 1983**

and is limited to the amount of water which can be applied to beneficial use and shall not exceed **0.065 cubic foot per second**

measured at the point of diversion from the **sources**, or its equivalent in case of rotation with other water users.

The well is to be LOCATED: **Well 1 - 325 feet South and 887 feet West and Well 2 - 525 feet South and 820 feet West both from the N 1/4 Corner of Section 15, being within the NE 1/4 NW 1/4 of Section 15, Township 36 South, Range 5 West, WM, in the County of Josephine.**

A description of the PLACE OF USE under the permit, and to which such right is appurtenant, is as follows:

\* the well to be made up by appropriation from the sump,

**Township 36 South, Range 5 West, WM Section 15 NE 1/4 NW 1/4 5.2 acres**

The AMOUNT OF WATER used for irrigation, together with the amount secured under any other right existing for the same lands shall be limited to 1/80 of one cubic foot per second per acre, and shall be further limited to a diversion of not to exceed 2.5 acre-feet per acre for each acre irrigated during the irrigation season of each year, and shall conform to such reasonable rotation system as may be ordered by the proper state officer.

The well shall be constructed in accordance with the General Standards for the Construction and Maintenance of Water Wells in Oregon. The works constructed shall include an air line and pressure gauge or an access port for measuring line, adequate to determine water level elevation in the well at all times. The permittee shall install and maintain a weir, meter, or other suitable measuring device, and shall keep a complete record of the amount of ground water withdrawn.

Actual construction work shall begin on or before **December 6, 1984**, and shall thereafter be prosecuted with reasonable diligence and be completed on or before **October 1, 1985**.

Complete application of the water to the proposed use shall be made on or before **October 1, 1986**.
