PERMIT TO APPROPRIATE THE PUBLIC WATERS

G-11051 and do hereby grant the same SUBJECT TO EXISTING RIGHTS This is to certify that I have examined APPLICATION and the following limitations and conditions:

for the PURPOSE of

irrigation

that the PRIORITY OF THE RIGHT dates from

August 11, 1983

and is limited to the amount of water which can be applied to beneficial use and shall not exceed 0.25 cubic foot per second of water

, or its equivalent in case of rotation with other water users. measured at the point of diversion from the

The well is to be LOCATED: 2620 feet North and 60 feet East from the Southwest Corner of Section 20, being within the NW 1/4 SW 1/4 of Section 20, Township 27 South, Range 17 East, WM, in the County of Lake.

A description of the PLACE OF USE under the permit, and to which such right is appurtenant, is as follows:

Section 20 SW 1/4 NE 1/4 20.0 acres Township 27 South, Range 17 East, WM

The AMOUNT OF WATER used for irrigation, together with the amount secured under any other right existing for the same lands shall be limited to 1/80 of one cubic foot per second per acre, and shall be further limited to a diversion of not to exceed 3.0 provided further that in the event of a request for a change in point of appropriation, an additional point of appropriation or repair of this well, the quantity of water allowed herein together with any other right from this point of appropriation shall not exceed the capacity of this well at the time of perfection of this right.

The well shall be constructed in accordance with the General Standards for the Construction and Maintenance of Water Wells in Oregon. The works constructed shall include an air line and pressure gauge or an access port for measuring line, adequate to determine water level elevation in the well at all times. The permittee shall install and maintain a weir, meter, or other suitable measuring device, and shall keep a complete record of the amount of ground water withdrawn.

Actual construction work shall begin on or before December 20, 1984 , and shall thereafter be prosecuted with reasonable diligence and be completed on or before October 1, 19 85

Complete application of the water to the proposed use shall be made on or before October 1, 19 86.
