PERMIT TO APPROPRIATE THE PUBLIC WATERS

This is to certify that I have examined APPLICATION **G-10433** and do hereby grant the same SUBJECT TO EXISTING RIGHTS and the following limitations and conditions:

This permit is issued to **USDA Forest Service, Deschutes National Forest of 211 Northeast Revere Street, Bend, Oregon 97701, phone 382-6922, for use of the waters from one well,**

for the PURPOSE of **a potable water supply for camp and picnic sites and Elk Lake Guard Station**

that the PRIORITY OF THE RIGHT dates from **January 6, 1982**

and is limited to the amount of water which can be applied to beneficial use and shall not exceed **0.06 cubic foot per second**

measured at the point of diversion from the **well**, or its equivalent in case of rotation with other water users.

The well is to be LOCATED: **900 feet North and 740 feet East from the Southwest Corner of Section 29, being within the SW 1/4 SW 1/4 of Section 29, Township 18 South, Range 8 East, WM, in the County of Deschutes.**

A description of the PLACE OF USE under the permit, and to which such right is appurtenant, is as follows:

The well shall be constructed in accordance with the General Standards for the Construction and Maintenance of Water Wells in Oregon. The works constructed shall include an air line and pressure gauge or an access port for measuring line, adequate to determine water level elevation in the well at all times. The permittee shall install and maintain a weir, meter, or other suitable measuring device, and shall keep a complete record of the amount of ground water withdrawn.

Actual construction work shall begin on or before **January 3, 1985**, and shall thereafter be prosecuted with reasonable diligence and be completed on or before **October 1, 1985**.

Complete application of the water to the proposed use shall be made on or before **October 1, 1986**.
