## PERMIT TO APPROPRIATE THE PUBLIC WATERS

This is to certify that I have examined APPLICATION G-10926 and do hereby grant the same SUBJECT TO EXISTING RIGHTS and the following limitations and conditions:

This permit is issued to City of Aumsville of PO Box 227, Aumsville, Oregon 97325, phone 749-2030, for use of the waters from two wells being 0.45 cubic foot per second from Well I (Lucas Well) and 0.95 cfs from Well 2 (New Park Well), for the PURPOSE of municipal

that the PRIORITY OF THE RIGHT dates from April 14, 1983

and is limited to the amount of water which can be applied to beneficial use and shall not exceed 1.40 cfs

measured at the point of diversion from the wells , or its equivalent in case of rotation with other water users.

The well is to be LOCATED: Well 1 - 920 feet South and 620 feet West from the Northeast Corner of Section 25, being within the NE I/4 NE I/4; Well 2 - 840 feet North and 3800 feet West from the Southeast Corner of Section 25, being within the SE 1/4 SW 1/4 both of Section 25, Township 8 South, Range 2 West, WM, in the County of Marion.

use of water under this permit shall be limited to appropriation of water only to the extent that such appropriation does not interfere with or deplete the flow of Mill Creek or any tributary thereof; any depletion will require the well or wells to be shut down, since Mill Creek and its tributaries have been closed to further appropriation, and shall conform to such reasonable rotation system as may be ordered by the proper state officer.

The well shall be constructed in accordance with the General Standards for the Construction and Maintenance of Water Wells in Oregon. The works constructed shall include an air line and pressure gauge or an access port for measuring line, adequate to determine water level elevation in the well at all times. The permittee shall install and maintain a weir, meter, or other suitable measuring device, and shall keep a complete record of the amount of ground water withdrawn.

Actual construction work shall begin on or before January 3, 1985, and shall thereafter be prosecuted with reasonable diligence and be completed on or before October 1, 1985. Extended to October 1, 1991, where the prosecuted with reasonable diligence and be completed on or before October 1, 1985.

Complete application of the water to the proposed use shall be made on or before October 1, 19 86. Extended to October 1, 1991,
