PERMIT TO APPROPRIATE THE PUBLIC WATERS

This is to certify that I have examined APPLICATION **G-11154** and do hereby grant the same SUBJECT TO EXISTING RIGHTS and the following limitations and conditions:

This permit is issued to **Ashdown Wood Water Company of PO Box 211, Lake Oswego, Oregon 97034, phone 636-0424, for use of the waters from one well,**

for the PURPOSE of **domestic use for 33 families including the irrigation of not to exceed one-half acre lawn and noncommercial garden for each**

that the PRIORITY OF THE RIGHT dates from **October 12, 1983**

and is limited to the amount of water which can be applied to beneficial use and shall not exceed **0.17 cubic foot per second**

measured at the point of diversion from the **well**, or its equivalent in case of rotation with other water users.

The well is to be LOCATED: **125 feet South and 2060 feet East from the Northwest Corner of Section 27, being within NE 1/4 NW 1/4 of Section 27, Township 2 South, Range 1 East, WM, in the County of Clackamas.**

A description of the PLACE OF USE under the permit, and to which such right is appurtenant, is as follows:

Township 2 South, Range 1 East, WM	Section 27	W 1/2	NW 1/4	Domestic use for 33 families including the irrigation of not to exceed one-half acre lawn and noncommercial garden for each
	Section 28	E 1/2	NE 1/4	

The well shall be constructed in accordance with the General Standards for the Construction and Maintenance of Water Wells in Oregon. The works constructed shall include an air line and pressure gauge or an access port for measuring line, adequate to determine water level elevation in the well at all times. The permittee shall install and maintain a weir, meter, or other suitable measuring device, and shall keep a complete record of the amount of ground water withdrawn.

Actual construction work shall begin on or before **January 24, 1985**, and shall thereafter be prosecuted with reasonable diligence and be completed on or before October 1, 19 **85**. **Extended to October 1, 1988** **Extended to October 1, 1991**

Complete application of the water to the proposed use shall be made on or before October 1, 19 **86**. **Extended to October 1, 1988**
Extended to October 1, 1991
