## PERMIT TO APPROPRIATE THE PUBLIC WATERS

This is to certify that I have examined APPLICATION G-11214 and do hereby grant the same SUBJECT TO EXISTING RIGHTS and the following limitations and conditions:

This permit is issued to Frederick J. Marti and William H. Pittock of 2084 Hombog Creek Road, Jacksonville, Oregon 97530, phone 898-1581, for use of the waters from one well, for the PURPOSE of irrigation of 320.0 acres

that the PRIORITY OF THE RIGHT dates from January 11, 1984

and is limited to the amount of water which can be applied to beneficial use and shall not exceed 4.0 cubic feet per second

measured at the point of diversion from the well , or its equivalent in case of rotation with other water users.

The well is to be LOCATED: 2640 feet South and 1320 feet East from the Northwest Corner of Section 16, being within the SW 1/4 NW 1/4 of Section 16, Township 26 South, Range 18 East, WM, in the County of Lake.

A description of the PLACE OF USE under the permit, and to which such right is appurtenant, is as follows:

Township 26 South, Range 18 East, WM Section 16 NW 1/4 NW 1/4 40.0 acres NE 1/4 NW 1/4 40.0 acres SW 1/4 NW 1/4 40.0 acres SE 1/4 NW 1/4 40.0 acres NE 1/4 SW 1/4 40.0 acres NW 1/4 SW 1/4 40.0 acres SW 1/4 SW 1/4 40.0 acres SE 1/4 SW 1/4 40.0 acres

The AMOUNT OF WATER used for irrigation, together with the amount secured under any other right existing for the same lands shall be limited to 1/80 of one cubic foot per second per acre, and shall be further limited to a diversion of not to exceed 3.0 acre-feet per acre for each acre irrigated during the irrigation season of each year, and shall conform to such reasonable rotation system as may be ordered by the proper state officer.

The well shall be constructed in accordance with the General Standards for the Construction and Maintenance of Water Wells in Oregon. The works constructed shall include an air line and pressure gauge or an access port for measuring line, adequate to determine water level elevation in the well at all times. The permittee shall install and maintain a weir, meter, or other suitable measuring device, and shall keep a complete record of the amount of ground water withdrawn.

Actual construction work shall begin on or before March 9, 1985, and shall thereafter be prosecuted with reasonable diligence and be completed on or before October 1, 1985. Extended to October 1, 1988.

Complete application of the water to the proposed use shall be made on or before October 1, 19 86. Extended to October 1, 1988
