PERMIT TO APPROPRIATE THE PUBLIC WATERS

This is to certify that I have examined APPLICATION G-11226 and do hereby grant the same SUBJECT TO EXISTING RIGHTS and the following limitations and conditions:

This permit is issued to John F. Madison (Madison Ranches) of Route 1, Box 25-C, Echo, Oregon 97826, phone 376-8178, for use of the waters from one well,

for the PURPOSE of irrigation of 37.0 acres

that the PRIORITY OF THE RIGHT dates from January 30, 1984

and is limited to the amount of water which can be applied to beneficial use and shall not exceed 0.46 cubic foot per second

measured at the point of diversion from the well , or its equivalent in case of rotation with other water users.

The well is to be LOCATED: 1280 feet North and 2430 feet East from the S 1/4 Corner of Section 24, being within the SE 1/4 SE 1/4 of Section 24, Township 3 North, Range 27 East, WM, in the County of Umatilla.

A description of the PLACE OF USE under the permit, and to which such right is appurtenant, is as follows:

Township 3 North, Range 27 East, WM Section 24 SE 1/4 NE 1/4 7.1 acres SW 1/4 NE 1/4 3.0 acres

Section 25 NE 1/4 NW 1/4 26.9 acres

The AMOUNT OF WATER used for irrigation, together with the amount secured under any other right existing for the same lands shall be limited to 1/80 of one cubic foot per second per acre, and shall be further limited to a diversion of not to exceed 3.0 acre-feet per acre for each acre irrigated during the irrigation season of each year, provided further that in the event of a request for a change in point of appropriation, an additional point of appropriation or repair of this well, the quantity of water allowed herein together with any other right from this point of appropriation shall not exceed the capacity of this well at the time of perfection of this right.

The well shall be constructed in accordance with the General Standards for the Construction and Maintenance of Water Wells in Oregon. The works constructed shall include an air line and pressure gauge or an access port for measuring line, adequate to determine water level elevation in the well at all times. The permittee shall install and maintain a weir, meter, or other suitable measuring device, and shall keep a complete record of the amount of ground water withdrawn.

Actual construction work shall begin on or before March 16, 1985, and shall thereafter be prosecuted with reasonable diligence and be completed on or before October 1, 1985.

Complete application of the water to the proposed use shall be made on or before October 1, 19 86.
