PERMIT TO APPROPRIATE THE PUBLIC WATERS

This is to certify that I have examined APPLICATION G-11177 and do hereby grant the same SUBJECT TO EXISTING RIGHTS and the following limitations and conditions:

This permit is issued to Leonard Skip Melville of Chico Route, Box 51, Enterprise, Oregon 97828, phone 426-3785, for use of the waters from two wells, being 200 gallons per minute from Well 1 and 400 gpm from Well 2 for the PURPOSE of irrigation of 161.2 acres irrigation of 161.2 acres

that the PRIORITY OF THE RIGHT dates from October 14, 1983 for 5.6 gpm and February 10, 1984 for 594.4 qpm

and is limited to the amount of water which can be applied to beneficial use and shall not exceed 600 gpm

measured at the point of diversion from the wells , or its equivalent in case of rotation with other water users.

The well is to be LOCATED: Well 1 - 1310 feet North and 400 feet West; Well 2 - 200 feet North and 400 feet West, both from the S 1/4 Corner of Section 29, both being within the SE 1/4 SW 1/4 of Section 29, Township 1 South, Range 45 East, WM, in the County of Wallowa. A description of the PLACE OF USE under the permit, and to which such right is appurtenant, is as follows:

40.1 acres Township 1 South, Range 45 East, WM Section 29 NW 1/4 SW 1/4 NE 1/4 SW 1/4 40.5 acre SW 1/4 SW 1/4 41.0 acres SE 1/4 SW 1/4 39.6 acres

The AMOUNT OF WATER used for irrigation, together with the amount secured under any other right existing for the same lands shall be limited to 1/80 of one cubic foot per second per acre, and shall be further limited to a diversion of not to exceed 3.0 acre-feet per acre for each acre irrigated during the irrigation season of each year, and shall conform to such reasonable rotation system as may be ordered by the proper state officer.

The well shall be constructed in accordance with the General Standards for the Construction and Maintenance of Water Wells in Oregon. The works constructed shall include an air line and pressure gauge or an access port for measuring line, adequate to determine water level elevation in the well at all times. The permittee shall install and maintain a weir, meter, or other suitable measuring device, and shall keep a complete record of the amount of ground water withdrawn.

Actual construction work shall begin on or before April 19, 1985, and shall thereafter be prosecuted with reasonable diligence and be completed on or before October 1, 19 85 .

Complete application of the water to the proposed use shall be made on or before October 1, 19 86.
