PERMIT TO APPROPRIATE THE PUBLIC WATERS

This is to certify that I have examined APPLICATION G-11110 and do hereby grant the same SUBJECT TO EXISTING RIGHTS and the following limitations and conditions:

This permit is issued to U.S. Department of Interior, Bureau of Land Management of Salem District Office/PO Box 3227, Salem, Oregon 97302, phone 399-5646, for use of the waters from one well,

for the PURPOSE of $\,$ irrigation of 5.0 acres and uses relative to picnic area, being 0.063 cubic foot per second for irrigation and 0.012 cfs for picnic area

that the PRIORITY OF THE RIGHT dates from September 29, 1984

and is limited to the amount of water which can be applied to beneficial use and shall not exceed 0.075 cfs

measured at the point of diversion from the

well, or its equivalent in case of rotation with other water users.

The well is to be LOCATED: 331.47 feet South and 270.32 feet West from the Northeast Corner of the SE 1/4 SW 1/4 of Section 31, being within the SE 1/4 SW 1/4 of Section 31, Township 2 South, Range 7 East, WM, in the County of Clackamas.

The AMOUNT OF WATER used for irrigation, together with the amount secured under any other right existing for the same lands shall be limited to 1/80 of one cubic foot per second per acre, and shall be further limited to a diversion of not to exceed 2.5 acre-feet per acre for each acre irrigated during the irrigation season of each year, use of water under this permit shall be limited to appropriation of water only to extent that such appropriation does not interfere with or deplete the flow of Salmon River or any tributary thereof; any depletion will require the well to be shut down since Salmon River and its tributaries have been closed to further appropriation except for certain uses.

The well shall be constructed in accordance with the General Standards for the Construction and Maintenance of Water Wells in Oregon. The works constructed shall include an air line and pressure gauge or an access port for measuring line, adequate to determine water level elevation in the well at all times. The permittee shall install and maintain a weir, meter, or other suitable measuring device, and shall keep a complete record of the amount of ground water withdrawn.

Actual construction work shall begin on or before May 30, 1985, and shall thereafter be prosecuted with reasonable diligence and be completed on or before October 1, 19 85.

Complete application of the water to the proposed use shall be made on or before October 1, 19 86.
