This is to certify that I have examined APPLICATION $\,G$ -10455 and do hereby grant the same SUBJECT TO EXISTING RIGHTS and the following limitations and conditions:

This permit is issued to Orchard Heights Water Association of PO Box 5196, Salem, Oregon 97304, phone 399-1775, for use of the waters from Well 3,

m for\ the\ PURPOSE\ of}$ group domestic for 175 families including the irrigation of not to exceed one-half acre lawn and noncommercial garden for each family

that the PRIORITY OF THE RIGHT dates from June 16, 1982

and is limited to the amount of water which can be applied to beneficial use and shall not exceed 0.33 cubic foot per second

measured at the point of diversion from the well , or its equivalent in case of rotation with other water users.

The well is to be LOCATED: 1150 feet South and 1700 feet West from the Northeast Corner of Section 13, being within the NW 1/4 NE 1/4 of Section 13, Township 7 South, Range 4 West, WM, in the County of Polk.

The well shall be constructed in accordance with the General Standards for the Construction and Maintenance of Water Wells in Oregon. The works constructed shall include an air line and pressure gauge or an access port for measuring line, adequate to determine water level elevation in the well at all times. The permittee shall install and maintain a weir, meter, or other suitable measuring device, and shall keep a complete record of the amount of ground water withdrawn.

Actual construction work shall begin on or before 301y 19, 1985 , and shall thereafter be prosecuted with reasonable diligence and be completed on or before October 1, 1985 .

Complete application of the water to the proposed use shall be made on or before October 1, 19 86 .
