PERMIT TO APPROPRIATE THE PUBLIC WATERS

This is to certify that I have examined APPLICATION G-11229 and do hereby grant the same SUBJECT TO EXISTING RIGHTS and the following limitations and conditions:

This permit is issued to Frank N. Chase of 1004 Cline Falls Road, Redmond, Oregon 97756, phone 548-4746, for use of the waters from one well,

for the PURPOSE of irrigation of 4.3 acres and supplemental irrigation of 5.0 acres

that the PRIORITY OF THE RIGHT dates from February 1, 1984

and is limited to the amount of water which can be applied to beneficial use and shall not exceed 0.12 cfs

measured at the point of diversion from the well, or its equivalent in case of rotation with other water users.

The well is to be LOCATED: 1968 feet North and 1497 feet West from the Southeast Corner of Section 14, being within the NW 1/4 SE 1/4 of Section 14, Township 15 South, Range 12 East, WM, in the County of Deschutes.

A description of the PLACE OF USE under the permit, and to which such right is appurtenant, is as follows:

The AMOUNT OF WATER used for irrigation, together with the amount secured under any other right existing for the same lands shall be limited to 1/80 of one cubic foot per second per acre, and shall be further limited to a diversion of not to exceed 3.0 acre-feet per acre for each acre irrigated during the irrigation season of each year, provided further that the right allowed herein shall be limited to any deficiency in the available supply of any prior right existing for the same land and shall not exceed the limitation allowed herein, and shall conform to such reasonable rotation system as may be ordered by the proper state officer.

Use of water under this permit shall be limited to the appropriation of water only to the extent that such appropriation does not interfere with or deplete the flow of water in Deschutes River. Any depletion will require the well to be shut down, since Deschutes River has been closed to further appropriations for irrigation purposes.

The well shall be constructed in accordance with the General Standards for the Construction and Maintenance of Water Wells in Oregon. The works constructed shall include an air line and pressure gauge or an access port for measuring line, adequate to determine water level elevation in the well at all times. The permittee shall install and maintain a weir, meter, or other suitable measuring device, and shall keep a complete record of the amount of ground water withdrawn.

Actual construction work shall begin on or before August 14, 1985, and shall thereafter be prosecuted with reasonable diligence and be completed on or before October 1, 1985.

Complete application of the water to the proposed use shall be made on or before October 1, 1986.
